On Friday March 21st, at approximately 7:00 PM, several people telephoned 9-1-1 to report sighting a man with a gun in Bernal Heights Park.

SFPD uniformed officers responded to the scene and located a suspect matching the description provided. As these officers approached this individual, they ordered him to show his hands. Instead, the suspect produced a weapon — equipped with a laser sight — from a holster and pointed it at the officers. Fearing for their safety, and the safety of the people in the park, the officers discharged their firearms at the suspect.

All investigators and supervisors of the SFPD followed standard and accepted protocols for investigating officer involved shootings. On March 25th, Chief Greg Suhr organized a town hall meeting to brief the community regarding this incident, and to answer any questions that the public might of had. The tone of this forum was changed dramatically due to the inexcusable statements and actions of one of the city's elected representatives. That person was Supervisor David Campos, and immediately after learning of the statements and conduct of Mr. Campos at this meeting, I wrote the letter that is reprinted here. The letter is about supporting members of the SFPOA, the protocols of the SFPD, and the disturbing conduct of an irresponsible local official.

Supervisor Campos,

It has come to my attention that you attended the town hall meeting held by SFPD Chief Suhr on Tuesday, March 25, 2014. While I commend elected city officials who remain involved with the community, I take exception to your public comments made at that meeting. It is my understanding that you were not present for the initial report about the Bernal Heights shooting incident. Yet, you felt compelled to publicly lambaste and berate members of the San Francisco Police Department. You said that you were "appalled by some of the police investigative tactics", "disgusted by the actions of the Inspectors", and believe that "it was shameful how it was done."

Statements such as these are common when uttered by individuals unfamiliar with the law enforcement protocols, best practices, and restraints mandated in this state by the Commission on Peace Officers Standards and Training (POST). However, for a sitting member of the Board of Supervisors — who also is the chairman of the Public Safety Committee and who has previously served on the San Francisco Police Commission — your public comments are inexcusable. It appears that you did not bother to speak to a single SFPD Investigator assigned to this case, or to any SFPD Command Staff member, yet you passed judgment on the involved officers and investigators, and inflamed an already tragic situation. It was irresponsible of you, as a public servant, to reactively lead with your prejudices and political ambition, rather than with the leadership expected from a San Francisco Supervisor.

I wonder if you made these comments because you are seeking a higher elected office? But I also wonder why you were not as outspoken and equally concerned two weeks ago when one of my members was wounded on the job in the Mission District?

These officers responded to 911 calls from frightened members of the community, and located a suspect waving a weapon about in a public park. The officers acted appropriately, within policy, and the investigation that followed adhered to established protocols. If there is blame to be placed, perhaps it lies with the City and County of San Francisco for its failure to provide appropriate social and mental health assistance to the individual who pulled a laser-equipped weapon on uniformed officers, forcing a confrontation in a public park. A sad and tragic event has now been made worse by your ill-conceived and irresponsible demagoguery to simply elicit votes.

Condolences for Slain Mendocino County Deputy

The men and women of the San Francisco Police Officers Association extend condolences to the family and co-workers of Mendocino Deputy Sheriff Ricky Del Fiorentino. The deputy, 48, was killed by gunfire in a shootout with an armed robbery and kidnapping suspect from the state of Oregon. The suspect, who led law enforcement officers on an extended hot chase on Highway 101, was located on a dirt road by Deputy Del Fiorentino. Before he could exit his patrol vehicle, the suspect ambushed the patrol car with an assault rifle,

killing the Deputy. The suspect was subsequently killed in a shootout with responding officers. The incident occurred on Wednesday, March 19, 2014.

Deputy Del Fiorentino was an experienced 26-year veteran of law enforcement, and the 5th Mendocino deputy to die in the line of duty.

Off-Duty Gun Deal for Active Cops in April

For the third year, Springfield Armory is offering a discounted gun purchase deal for active San Francisco police officers.

Angelo Spagnoli of the Police Range and yours truly are the intermediaries between the Armory and those officers who are interested in purchasing excellent off duty weapons.

Available from the Armory are 40 caliber and .9mm compact and sub-compact semi-automatic handguns at a discounted price of \$439.00. In addition, San Francisco's only gun store, High Bridge Arms, will receive the weapons and process the requisite registration for a fee of \$75.00 instead of the usual \$150.

Due to the high volume of gun purchases across the country in the face of gun control proposals, there is a delay in receiving handguns. Members purchasing these weapons may experience 6-9 month wait for the weapons.

Any member who is an active officer at the time of purchase is eligible to participate in this program. Our deadline for submission of checks is April 30th.

The following provisions that are specific to the publication of the *POA Journal* shall also be applicable to publication of material on the POA web site to any extent that is practical. Publication of material in the *POA Journal* or on the POA web site does not necessarily include publication on or in both instruments of communication. Nor does the following editorial policy for the *POA Journal* preclude a different or contrary editorial policy for the POA web site.

Member Opinions and Commentary: Unsolicited Written Material

A member or group of members may submit **unsolicited written material** to the *POA Journal* that expresses his/her/their opinion(s) and concerns within the following limitations and guidelines:

- Such material must be addressed as a letter or mail using common salutations such as "Dear POA," "Editor," "SFPOA" "Dear POA Members" etc.
- Such material must be authored and signed by the member(s) making the submission. Anonymous submissions will not be published.
- Such material must be factually correct and presented in a respectful and civil manner.
- Such material can not be slanderous, unnecessarily inflammatory, sexist, racist, or otherwise offensive, nor can it be disparaging of any member or bring upon them unwarranted accusation or rebuke, either express or implied.

Officer Richards entered the SFPD on January 25, 1999 and served with distinction at Mission, Tenderloin, Ingleside, Northern, Bayview, and Richmond Stations. Officer Richards (known as "JR") was a good spirited officer always with a smile on his face. While serving in the SFPD Officer Richards continued his passion for music by playing various instruments at many local clubs. Officer Richards was the recipient of a SFPD Unit Citation and



numerous Captain Complimentary Reports.

James is survived by his wife, and the love of his life, Mayra Lopez Richards. James will be forever missed by his many friends and colleagues within the SFPD.

Minutes of the March 12, 2014 SFPOA Board Meeting*

1. President Martin Halloran called the meeting to order at 13:01 hours.
2. President Halloran led the board in the Pledge of Allegiance.
3. President Halloran announced that there would not be a swearing in of the Airport Representative at this time because of a run-off election in progress.
4. Secretary Mike Nevin conducted Roll Call.
5. Representative Scott Edwards (Mission) spoke to the board regarding the recent officer-involved shooting in the Mission District. On behalf of Mission Station officers, he thanked President Halloran for the POA efforts assisting the members involved.
6. Paul Chignell, Legal Defense Administrator, addressed the board regarding the POA Defense Committee. The volume of POA defense needs is high at the moment. He asked the board to remind members to immediately notify the POA when they receive notice of an interview or when they receive sustained findings. Members should not attend interviews without representation nor should they accept discipline without POA consultation.
7. Secretary Nevin reviewed the POA survey results with the board. A discussion with the board followed. [The survey is posted in this *Journal* issue.]
8. Representative Chris Schaffer (Bayview) made a motion to approve the February 2014 minutes. The motion received a second from Representative Matt Lobre (Northern). It passed unanimously by voice vote.
9. President's Message. President Halloran spoke to the board regarding events surrounding the Mission Station officer-involved shooting from March 8. Most importantly, Officer Adam Shaw is recovering from his injuries.
10. President Halloran addressed the federal indictment of five active members and one former member. The involved members have POA legal defense, and the POA has met with the attorneys. The POA Legal Defense Fund committee has convened in this matter. Halloran informed the board that he will e-mail upcoming court dates. Members are reminded they should only attend federal court while off-duty and in civilian court attire. Halloran announced the POA has established the "Suspension Relief Fund" for the active members who have been suspended without pay. A fundraiser will be held on May 22 at the Italian Athletic Club. Raffle tickets were passed out to the board and a silent auction will be held as well. Any member wishing to donate an auction item should contact the POA.
11. President Halloran discussed the recent Department Bulletin regarding promotional test requirements. There was a change with regard to eligibility that is dependent upon the month a test is given. The Department has not yet announced when the next captain's and lieutenant's test will be.
12. President Halloran announced that based on the low station survey participation for certain stations/units, a visit to those assignments will occur with members of the executive board. Richmond Station will get the first visit.
13. President Halloran and Attorney Gregg Adam said that the Chuck Reed Amendment regarding public employee pensions appears to be off the table for 2014. However, this fight is far from over as Gregg Adam described recent meetings he has attended. It is expected that this issue will take center stage in 2016.
14. President Halloran stated that he expects to re-shuffle POA Committees. Members who currently serve on a committee OR who would like to serve should send notice to President Halloran as soon as possible.
15. President Halloran addressed 10-B. While there have been some meetings there has been no agreement made between the City/Department and the POA. 10-B is part of the Administrative Code and any changes must go through the board of supervisors. Currently, only SFPD, DPT, and DEM are allowed to participate in 10-B.
16. Vice President's Message. Vice President Montoya had to be excused by the time this agenda item was discussed. President Halloran, Vice President Montoya, Treasurer Joe Valdez, and POA Attorney Gregg Adam met with D.C. Shinn and other members of the Department immediately prior to the board meeting. A host of seniority and payroll issues were addressed. The POA is seeking a timely resolution and will be prepared to file a grievance if matters cannot be agreed upon.
17. Treasurer's Report. Treasurer Joe Valdez provided the board with copies of the monthly budget/expense report.
18. New Business. Representative Raphael Rockwell (Hdqrt/Admin) asked if anyone wanted to volunteer to help with little league baseball for Mission Station. Contact him at rockwell1195@gmail.com.
19. Representative Jesus Pena (Northern) brought up an issue with late court cancellation notices. President Halloran stated that this requires personal service and a voice mail would not suffice.
20. Treasurer Valdez asked for representatives to consider allowing their photos to go on the POA website.
21. Representative Ed Carew (Central) asked if any board member was aware of a new computer system going into effect.
22. Old Business. Representative Scott Edwards (Mission) set up with our web designer, Erika Jones-Clary, an online voting system for the board of directors outside of regular meetings.
23. Financial requests. None
24. President Halloran made a motion to adjourn the meeting. The motion received a second from Treasurer Valdez. The motion passed unanimously by voice vote. The meeting was adjourned at 14:35 hours.

The monthly meeting of the Widows and Orphans Aid Association of the San Francisco Police Department, was called to order on Tuesday March 11, 2014, by President Al Luenow. The meeting was held at 850 Bryant Street, room #150 at 1:45pm.

Roll Call of Officers: President Al Luenow, Vice President John Keane, Secretary Mark McDonough, Treasurer Dean Taylor, Trustees John Centurioni, Leroy Lindo, and Ray Kane were present. Trustees Sally Foster and Joe Reilly were excused.

Approval of the Minutes: Trustee John Centurioni made a motion to approve the February 2014 minutes. The motion was seconded by Trustee Leroy Lindo and passed without objection.

Receiving Applications for New Members; Suspensions, and Reinstatements: Trustee Lindo attended the Retirement Seminar for the SFPD at Sigmund Stern Grove on February 27, 2014. Leroy presented the attendees with information regarding "direct deposit" for their retirement transition. Leroy answered questions regarding the WOOA and provided answers and necessary information including the WOOA website "sfwidowsandorphans.org". Our new website will assist members in processing their beneficiary and contact changes. Our website also contains our monthly minutes and will have our year ending reports. SFPD Recruit Classes 238 and 239 have a high number of WOOA sign-ups. All recruits who have signed up for the WOOA will be eligible for permanent membership upon their completion of probation.

Communications and Bills: The WOOA paid three death benefits to the benefactors of Frank Fahey, Michael Hutchings, and Abel Martinez. Trustee John Centurioni made a motion to pay the benefits and bills. Trustee Leroy Lindo seconded the motion, which passed without objection.

Report of Visiting Committee: No report for this month.

Report of Trustees:

Dillon Cole, age 73: Dillon Cole,

Jr. was born on August 5, 1940 in Nashville, TN. Dillon was listed as a Surveyor as a prior occupation before joining the San Francisco Police Department on October 16, 1967. Dillon graduated from the Police Academy in February of 1968 and was assigned to Ingleside Police Station on February 12, 1968. Dillon was assigned to star #1886. Dillon was transferred later that year on September 17, 1968 to the AIB at the Traffic Bureau. On August 9, 1972 he transferred to CPC, and returned to Ingleside Police Station on April 3, 1975. On May 9, 1977 he was transferred to the Support Services Bureau. Dillon retired with a disability pension on December 5, 1977 after serving the city for just over 10 years. During his ten years, Dillon is listed as having been awarded a meritorious conduct award, and three Bronze Medals of Valor all during the year of 1973. Dillon chased an armed 211 suspect on foot and exchanged gunfire with the suspect who he subsequently arrested (Bronze Medal). Dillon was awarded the Meritorious Award for his investigation and arrest of a Burglary suspect. Dillon was awarded another Bronze Medal for the arrest of an attempted homicide suspect who had shot and wounded her boyfriend. Dillon and his partner recovered the weapon. Dillon's final Bronze Medal was for the arrest of an armed robbery suspect who engaged in a vehicle chase. The suspect brandished a firearm at the officers who were able to capture the suspect and recover the weapon.

Abel O. Martinez, age 76: Abel was born in 1937 in Shinner, Texas to Domingo and Teofila Martinez. Abel joined the San Francisco Police Department on October 18, 1968 at the age of 31. Abel was assigned to Star #561. Abel graduated from the Police Academy in April of 1969 and was assigned to Mission Police Station on April 7th. On January 21, 1973, Abel transferred to Central Police Station. Abel remained at Co. A until August 14, 1993 when he suffered an injury. Abel was assigned to Medical Liaison for a few months and was reassigned to the Co. K Traffic Bureau. Abel spent a brief period at Southern Police Station, but returned to the Traffic Bureau where he remained until his retirement on

May 14, 2003. Abel retired with a service pension after 34 plus years in the SFPD, and was awarded a Bronze Medal of Valor for arrest of an armed robbery suspect. The suspect and officers exchanged gunfire until the officers subsequently took the suspect and firearm into custody. Abel is survived by his wife of 49 years (Mary Lou (Farr)), his sons William and Michael (SFFD), daughter Kimberly Martinez, brothers Andres and Adalino, sisters Adela Chapa and Amelia Sorrell, his grandchildren Rachel, Connor, and Ryan, and his many loving nieces, nephews, and extended family. Abel was a loving father, husband, grandfather, and friend to all.

James T. Moore, age 77: James was born on May 14, 1936 in Waskom, TX. Prior to joining the San Francisco Police Department, James' prior occupation is listed as a Parking Controlman. James entered the SFPD on July 1, 1966 at the age of 30. On September 12, 1966, James was assigned to Northern Police Station where he remained until his appointment to Inspector in 1972. James was then assigned to the Juvenile Detail where he remained until suffering a career ending injury. James retired with a disability pension on January 18, 1979 after serving the city for 12 years. James Moore was awarded two Bronze Medals of Valor, and one Gold Medal of Valor. On September 4, 1970 at 5:15am, Moore and his partner Hans C. Anderson responded to a call of several escaped burglary suspects. Moore and Anderson spotted the suspect vehicle and engaged in a high-speed pursuit where the suspects fired their guns at the officers. Moore and Anderson returned fire resulting in all parties sustaining gunshot wounds. The suspects were possession of handguns and a shotgun which the fired at Moore and Anderson. Moore and Anderson were able to hang on until the suspects gave up and were arrested. James Moore and his partner were awarded a Gold Medal of Valor. Moore was awarded a Bronze Medal of Valor for the arrest of armed robbery suspects who committed a 211/takeover at a supermarket. The suspects tied up the victims. One suspect attempted to use his firearm James Moore and his partner Hans C. Anderson. Moore and Anderson were able to disarm the suspect and affect the arrest. I was not able to obtain any information on Moore's last Bronze Medal of Valor.

Wow, check out April 1971's editorial headline: "REVOLUTION - In the United States." This title leaves little of the content to the imagination!


The article repeats a revolutionary document spelling out various means of publicly agitating the government to the point of overthrow. Such measures include political assassinations, bombings and kidnappings. The document's author speaks in theoretical terms by referencing

Retired SFPD Member Attacked by Notorious Cop-Killers Urges that they be Denied Parole

Dear Parole Board members:

On August 28, 1971, an attempt was made to assassinate me by members of the Black Liberation Army, namely Anthony Bottom and Albert Washington. At the time, I was a sergeant with the San Francisco Police Department. Two of the three firearms used in that incident were traced to the 1971 killings of Officers Waverly Jones and Joseph Piagentini of the New York City Police Department.

This group, which included Herman Bell, Inmate #DIN 79C0262 and others had the malevolent intentions of killing police officers throughout the United States. In some cases, they succeeded. Criminal investigations, which traversed across the country, proved this to be the case.

In San Francisco, this radical group, including Inmate 79C0262, was connected to the Park Police Station bombing which killed a police sergeant and wounded other officers. An attack on the Ingleside Police Station by the Black Liberation Army also left a police sergeant dead and wounded a civilian employee. The planting of several sticks of dynamite on the roof of the Mission Station was attributed to the Black Liberation Army. Fortunately, the fuse failed to ignite the bomb. Officers Robert Martinez and Dennis Jacobson were both wounded in a shooting attack in the Fillmore District of the city.

All of the above cases, and others, were attributed to the Black Liberation Army. Herman Bell, inmate #79C0262, was an active member of the Black Liberation Army and participated in these crimes.

These accounts are documented in a book, "Badge of the Assassin", E.D. Dalton publisher, 1979, written by attorneys Robert Tannenbaum and Philip Rosenberg, formally prosecutors in County District Attorneys Office, New York City, New York. Herman Bell, inmate 79C0262, along with defendants Anthony Bottom and Albert Washington, were convicted of murdering two New York City police officers. The nature of these heinous crimes should preclude the release of Herman Bell #79C0262.

I, as well as other retired police officers who lived through those turbulent years in the 1970s, strongly oppose the release of Herman bell, inmate #79C0262.

Widow of Slain Officer Voices Objection to Parole

On May 21, 1971 two police officers were assassinated, shot in the back after answering a call for help at the Harlem projects. As they walked toward their patrol car, two men, Herman Bell, and Anthony Bottom, walked up behind them and shot them multiple times, leaving my husband Joseph Piagentini, pleading with them not to kill him, he had a wife and two children. Waverly Jones, dying instantly, also shot in the back of the head multiple times.

These men have denied the killings since their trial and sentencing, not until now have they admitted what they did on that rainy night on May 21. It is in the trial transcripts that Anthony Bottom, Herman Bell, and Albert Washington, declared that they "would never be rehabilitated and should they be released they would do it again" Even though these men have been imprisoned for many years, and it took 39 of those years for them to finally admit to the killing of two New York City Police Officers, just because they wore the blue uniform. They are still the same men who committed this heinous crime, their political views are still the same, there is no remorse, they have not taken responsibility for what they did.

Jack Coughlin sent me an email that he sent to you, requesting a "Sense of the Senate resolution", I also would greatly appreciate it, if you would introduce this resolution. so that you and your fellow senators can come together and call for the further imprisonment of Anthony Bottom and Herman Bell, that their "Parole be Denied."

Let this be heard, should anyone take the life of a Police Officer in the state of New York, that they will spend the rest of their life in prison.

On behalf of myself and my children who have lived without their father, and now my grandchildren will never get to know the wonderful man that Joe was,

I respectfully ask that you submit a "Sense of Senate resolution".

Honorable Commissioners:

It is with the utmost urgency and concern that I write to you on behalf of the San Francisco Police Department regarding the continued incarceration of New York State inmates Herman Bell (DIN# 79C0262) and Anthony Bottom (DIN# 77 A4283).

In 2009, both men entered guilty pleas in San Francisco Superior Court for the August 29, 1971 assassination of San Francisco Police Sergeant John V. Young. The crime for which they were recently convicted pales in comparison to the acts of terror the two men inflicted upon the cities of San Francisco and New York from 1970 to 1971. In the course of the San Francisco investigation and prosecution, it was determined that both men committed numerous acts of violence upon law enforcement members. These acts included the bombing of a police officer's funeral, two attempted bombings of police stations, at least three planned ambush shooting attacks upon San Francisco police officers and several bank robberies to fund their cadres operations.

I have reviewed the Parole Board Hearing transcripts for Herman Bell (March 21, 2012) and Anthony Bottom (September 21, 2012) and I find no remorse in the false and self-serving statements made by both men. The shooter of SFPD Sergeant Young, Herman Bell, lies to the board in claiming only to have been a "look out" during the attack of the police station. Bell fails to disclose that he was identified by a co-conspirator as the shooter and that in 1973 the murder weapon was recovered from his bedroom pursuant to a search warrant. The planner in the shooting death of Sergeant Young, Anthony Bottom, completely avoids discussing his culpability in the police station attack. Bottom also lies to the board regarding his attempt to shoot SFPD Sergeant George Kowalski with a sub-machine gun while in a car with co-defendant Albert Washington.

I ask the Parole Board considering the release of both Herman Bell and Anthony Bottom to deny each of their petitions for release.

The Random and Murderous Attack on SFPD Sergeant Code W. Beverly, Jr.

The Beginning of the Tragedy

It was Monday, January 24, 1972 in the Mission Police District, early in the morning on the midnight watch. Two young officers on patrol, Michael McNeill and Patrick White, were nearing the end of their shift. They decided to go to the Doggie Diner on Mission Street for a cup of coffee. En route, they spotted a lone driver in a 1962 Ford Fairlane blow a red light at 18th and Mission. That red light violation was the fateful catalyst for the murder of Sergeant Code Beverly and the shooting of Officer James Bailey.

After stopping the driver of the Ford, Junious Poole, Officer McNeill gave Poole a break and did not cite him for the red light. Instead he cited the driver for 12951 of the California Vehicle Code — driving with no license in possession. The unemployed janitor, who had prior arrests for shooting into an inhabited dwelling, purse snatching, auto theft, and just three months before at the same location 18th and Mission for assaulting an officer and resisting arrest, was sent on his way.

Lieutenant McNeill Remembers

In March of this year, some forty-two (42) years later, Paul Chignell spoke to retired Lieutenant Michael McNeill about that traffic stop. Michael had entered the SFPD in March of 1971, and retired in 1998. He remembered distinctly the aftermath of the citation like it was yesterday. He recalled that after driving away, the 20-year old Poole came back around the block and gazed at the officers with a "mean look" before leaving the area.

Sergeant Beverly Remembered

Sergeant Code Beverly was 32 years old and had entered the San Francisco Police Department on June 16, 1965. He had a wife and two young daughters. Recently promoted to sergeant, he was walking the beat on Valencia Street near 20th Street with Officer James Bailey. Beverly had previously served with distinction in the Canine

Unit, and Bailey was known as a good street cop.

Retired Captain Michael Hebel remembers Beverly well. He stated, "Code and I met on many occasions when he was a member of the K-9 unit. On burglary calls, we at Park Station would call on him to assist with building searches. I remember him so clearly because he was always prompt in responding, willing to help, and gave good advice on proper search techniques."

POA Journal Editor Ray Shine was a rookie officer assigned to Ingleside Station in the early fall of 1971. Assigned to the midnight watch, he was often detailed to Station Duty under the supervision of the Station Keeper, newly promoted Sergeant Code Beverly. "I recall many times when Sergeant Beverly was detailed as Keeper that he would bring with him to work on those nights his old K-9 partner. I don't recall the dog's name, but he always curled up in a corner of the office behind the sergeant's desk, and would not budge until commanded to do so by his handler. Several times during the watch, Sergeant Beverly would take the dog outside for a bit of fresh air and other reasons. He obviously cared a lot about his old K-9 partner."

A Random Killer

Junious Poole was the father of two boys, one and a half, and six weeks old. He and his common law wife lived in a rooming house at 261 Valencia Street when they were not estranged. Poole also stayed with his mother in the Bayview at 744 Jerrold Avenue. His criminal record had begun in October of 1964, and had become progressively worse.

By his own admission, Junious Poole was angry at receiving the citation, and wanted to get even with the officers. So he drove over to Dolores Park at 8:00 am the same morning and parked his car, opened the trunk and loaded his .22 caliber rifle that he had bought from a pawnshop. He then drove back to the Mission and Valencia Streets area looking for the officers who cited him. Poole spotted Sergeant Beverly and Officer Bailey walking north on Valencia on the east sidewalk at 20th Street. Poole didn't care which officers he found. He wanted revenge for receiving the traffic citation. In his confession to Inspectors Gus Coreris and Bill Armstrong of the Homicide Unit, he said, "I just tightened up man, and couldn't take it."

Poole double-parked his car adjacent to the officers, got out of the car with the rifle and opened fire on Beverly and Bailey. Beverly was hit in the chest and abdomen and went down mortally wounded. Bailey was struck in the hip but returned fire emptying his revolver. Poole ducked be-

hind parked cars to avoid Bailey's shots and then observed a Mrs. Ann Bridges, a 53-year old in her stopped vehicle. The suspect commandeered her car after pushing Mrs. Bridges to the passenger seat. He drove down Valencia to Duboce, struck a parked car, and then ran off with the rifle in his hands.

Meanwhile, both officers were taken to Mission Emergency Hospital by paramedics and officers flooded the streets in search of Poole. The suspect arrived at 261 Valencia Street and forced in the door to his common law wife's apartment, number 31.

Officers Richard Abbey and James Kineavy of the SFPD Traffic Bureau arrived and were given information by two citizens that a black man holding a rifle had been seen entering 261 Valencia Street. The officers sped to the scene and confronted the manager of the apartment house who identified Poole as the resident in apartment 31. They entered the apartment and observed Poole with his shirt and shoes removed, and backing up into the recesses of the apartment. The officers also spotted a revolver and the .22 caliber rifle on a bed. A struggle ensued with the officers, but he was subdued and handcuffed and led out of the building where scores of San Francisco Police officers had surrounded the building.

The Aftermath

At 10:20 am, the legendary Inspectors Gus Coreris and Bill Armstrong and Deputy District Attorney Charles Breyer, now a Federal Judge, interrogated Junious Poole. They skillfully elicited a full confession and were able to trace all the movements of Poole throughout the morning. Poole was

charged with attempted murder, and kidnapping.

After a valiant fight for his life, Sergeant Code Beverly succumbed to his massive injuries at 7:08 am on Friday, January 28, 1972. The charges against Poole were changed to 187 of the Penal Code, Murder. Officer James Bailey recuperated, was ultimately promoted to Inspector and retired in November of 1993.

Poole went to trial in San Francisco Superior Court after pleading not guilty by reason of insanity. On Wednesday, June 28, 1972 he was convicted of murder, assault and kidnapping. The jury also found him sane. He arrived at State Prison on August 2, 1972 and died at the age of 49 on February 19, 2001, still in State Prison.

Code Beverly was another in a long list of San Francisco Police Officers killed in the line of duty in the late 1960s and early 1970s.

This was another unprovoked attack on an officer solely because he wore the blue uniform. But Code Beverly is not forgotten, even 42 years later. The Officer Down Memorial Page proudly displays remembrances from friends and family with many from recent months. Officers who worked with Code and knew of him often remark about his warmth, knowledge, and strength of character. God Bless Code W. Beverly, Jr.





I've known Frank Falzon for 30+ years — not really personally, but professionally — as a highly revered investigator and general "nice guy", and Frank and Donna's offer to the Lande family left me speechless and so very proud to have worn the same uniform as Frank, although never in the same league as him in terms of investigative ability and positive reputation.

I would hope that all of you include the Lande Family in your prayers this evening, and also thank the Good Lord that he put people like the Falzens on this earth.

Dear POA and Mike Hebel —

In the February issue of this newspaper, you stated the Retirement Board switched our deferred comp plan from Great West to Prudential Insurance for three reasons: 1) Prudential offered a better website, 2) Prudential would increase city employee participation, and 3) Prudential had a lower cost structure than Great West, and our investments would grow faster through reduced expenses.

I am aware of no investment company that has ever marketed their services based upon a superior website. Likewise, a financial service company increasing their client base has no effect on any of our member's retirement.

Thus, your final justification for moving to Prudential is their lower fund expenses. From the Prudential website and the last Great West statement, I have prepared a side-by-side fee comparison (see below). Frankly Mike, if members distribute their investments equally through Prudential's offerings, our fund fees have actually increased.

Many members have asked me why, during a 17-year period, we have switched between 5 different insurance companies. Unlike our 401k cousins, we have neither SEC nor Department of Labor oversight protecting us. Our members rely solely on you to watch our backs. Moving a \$2.4 billion dollar account because of an inferior website is like flipping your home because you don't like the drapes. Considering that there is no apparent reduction in our fees, perhaps you could shed some light on why our accounts were switched (yet again).

Tuesday night there are three meetings. In Union City you have Frank S. In La Mesa we have Joe A.; in Fairfield you call Matt B.

There are two on Wednesday nights; contact Rick C. for the meeting in San Rafael. If you are traveling south, check out the Wednesday meeting in Orange County. Grab some pancakes afterward; the meeting is behind an IHOP.

Thursday night there are three. In Livermore Ed C. and Dave are the contact people. Another one is in San Bernardino. Oh, I just remembered, the San Francisco meeting with Art H. is also on Thursday mornings.

"Wow, I had no idea! Hey, there is LT. Looks like briefing is starting, Juanita noticed. "Thanks a lot Pedro, and I am really sorry about before."

EVOC: Changes to DGO 5.05

DGO 5.05 was revised on May 22nd, 2013 and took effect on June 26, 2013. Here is a summation of the changes that took place along with some of the relevant emergency driving policies that come up frequently.

Our policy states that at all times members SHALL drive with due regard (21056 CVC) for the safety of all persons. An officer may respond Code 3 when an emergency response appears reasonably necessary to prevent serious injury to persons, whether or not a criminal offense is involved. Officers shall broadcast the start location of their response. Supervisors shall continually evaluate the need for the Code 3 response. If a supervisor feels the risks to public safety appears unreasonable, the supervisor shall order the emergency response terminated.

The definition of a vehicle pursuit is an attempt by an officer, in an emer-



gency vehicle, to stop a moving motor vehicle, when the operator of the moving vehicle is attempting to avoid capture either by using willfully evasive tactics, such as high-speed driving, or driving in a legal manner, but willfully failing to yield. The officer's initial broadcast for a pursuit shall include the unit designator and the reason for the pursuit. The officer shall then broadcast their location, direction of travel, speed of the pursuit, and keep this information constantly updated over the radio. If a supervisor does not receive this information within a reasonable amount of time, the pursuit will be cancelled. At the termination of all pursuits a CHP 187A form shall be completed by a supervisor and attached to the report.

Any officer joining a pursuit SHALL notify dispatch of their response unless extraordinary circumstances exist, which would not allow them to request supervisory approval. The vehicle's red light and siren shall be used at all times during the entire vehicle pursuit. If a supervisor gives an order to terminate a pursuit, the pursuing officers SHALL acknowledge the broadcast over the radio and give a termination location. The officers shall

not continue to pursue in any mode.

Any pursuit that goes the wrong way on the freeway SHALL be discontinued immediately. Units not assigned to the pursuit shall not respond Code 3 to the area nor parallel a pursuit. Officers are not permitted to initiate or join a pursuit if they have civilian passengers in their vehicle including a ride-along, media, witness, or a suspect. Unmarked police cars (no red lights or siren) and police wagons shall not be involved in a pursuit.

Members involved in a pursuit must always use due regard for traffic conditions (21056 CVC) and insure the safety of the public. If at any time an officer loses radio contact with dispatch, a passenger in the pursuing vehicle or secondary vehicle may use their cellular phone to give updates.

DGO 5.05 does not forbid an officer from using their vehicle as a tactical tool to block a STATIONARY suspect vehicle to prevent escape, when following conditions exist: there is reasonable suspicion that the suspect was involved in a violent felony, the vehicle has come to a stop at the end of a pursuit, and substantial risk to the public exists, if the operator is allowed the opportunity to flee.

Deflecting is an authorized technique, when an officer has a reasonable basis to believe that substantial risk exists that the suspect will cause imminent death or serious bodily injury to the public or officers unless this tactic is used. An entry into the Use of Force log must be made for any use of deflection tactics. Deflecting incidents will be reviewed by the department as a USE OF DEADLY FORCE.



Please remember that EVOC has classes monthly. These classes are open to every member of all ranks and are not just for re-entry and DABOR. It is a great opportunity to come out to Pier 96 and work on and maintain your driving skills. You will get instruction in the classroom which includes legal updates, useful current videos, and a review of current policies. You will also get 2 days of driving at both high and low speeds. If you have not been to EVOC in a while please check with your unit training coordinator to sign up for the class.

Welcome Back Reserve Officer Stewart Ng #1055





The general comments will not be published in this forum but the executive board and your representatives on the board of directors have reviewed them. This open-ended feedback is important.


The answers to these survey questions are provided in detail but here are some of the highlights:

- 381 members participated with the Airport and Northern leading the way.
- 28% of the respondents had 20+ years of experience. A vast majority had 6+ years.
- Just under half had outside SFPD experience.
- Approximately 80% would attend a general membership meeting.
- Most receive POA information from Journal, Station Representative, and e-mail.
- Most prefer e-mail for information. [Note: many members still have no e-mail on file.]
- The *POA Journal* was quite popular with 78% reading it monthly and 73% satisfied with it.
- While only 25% needed POA defense representation in past 18 months, 84% were satisfied.
- “Other” representation was needed by only 22% in past 2 years but 81% were satisfied.
- When ranking what’s important—Benefits, Working Conditions and Legal Defense top the list.


What is your current station assignment?




How many years from “date of hire” have you been with the SFPD?




How many years were you in law enforcement at another loction?




The POA board meetings are on the 3rd Wednesday of each month. Would you be willing to attend a general membership meeting if it were held at a venue that could accommodate a large group of members?



If Yes, when would you prefer to attend?




How do you currently receive POA-related information? Choose from one or more of the following:





How would you prefer to receive information from the POA?





Have you requested other POA representation from the POA in the past 24 months?





How often do you read the POA Journal either in print or online?





POLICE-FIRE Post 456 NEWS

"Now from a distance, I look back on what the Corps taught me: To think like men of action, and to act like men of thought! To live life with intensity and a passion for excellence."

—Maj. Gen. James "Mad Dog" Mattis (ret.)

Fred Phelps Sr., the despicable founder of Westboro Baptist Church, died on March 19. The church believes that gays and lesbians are evil and one way they have tried to spread their message is by picketing service members' funerals with signs such as "Thank God for Dead Soldiers."

News of Phelps' death was welcomed by a number of people who commented on Military Times' Facebook pages, debating whether Phelps' funeral should be picketed. Al Snyder, the father of a fallen Marine whose son's funeral was targeted by Westboro Baptist in 2006, hopes Phelps is afforded more respect than church members showed his son. "I believe he has the same rights as everybody else should have, that he should be buried in peace," Al Snyder told Marine Corps Times. "Two wrongs don't make a right. I do not like Westboro Baptist Church; I don't have anything nice to say about them, but if I had anything bad to say about them at this time it would put me in the same category as him, and I don't want to be in that category," he said. "I don't like hate."

It's a sentiment shared by his former attorney, Craig Trebilcock, an Army Reserve officer who was Al Snyder's attorney when he unsuccessfully sued the Westboro Baptist Church. "I think the best revenge for people is to show Pastor Phelps and his family the mercy and compassion that they've denied to everyone else, and I'd encourage everyone to pray for him," said Trebilcock.

I don't know why I am compelled to report regularly on the Camp Lejeune contaminated water story. Perhaps because I drank the poisoned water for a year (in preparation of being sprayed with Agent Orange for a year). Anyway, the Centers for Disease Control and Prevention official leading the investigation into the health effects of Camp Lejeune's polluted water has resigned. Tanja Popovic, who served as acting director of the Agency for Toxic Substances and Disease Registry, stepped down after only seven weeks on the job, the Tampa Bay Times reported.

Capitol Hill staffers, including aides to both U.S. senators from North Carolina, recently voiced concerns about Popovic's management of Camp Lejeune issues and her department's liaisons with the CDC and the Department of Health and Human Services, according to the Times.



In 2012, Congress passed a law that provided care for Marines and their family members who have illnesses that can be traced to the contamination. However, the CDCP continues to examine the pollution's impact. Victims want a study that would try to determine occurrences of cancer among former residents of the Camp. Last month, Popovic told lawmakers that her agency lacked the resources to carry out such a study.

Good News! The Navy's Blue Angels performed their first air show of the season this month at Naval Air Facility El Centro, according to a Navy release. The elite flight demonstration team usually flies 35 to 40 shows a year, but only flew twice last year due to sequestration. While air show attendees will generally only see the six acrobatic pilots who fly within inches of each other's wingtips, it takes more than 130 sailors and Marines to make up the team, performing jobs ranging from aircraft maintenance to photography. There's also a recruiting element to the high-flying shows.

Cmdr. Tom Frosch, the squadron's flight leader, said he hopes his team can inspire young men and women to pursue a career in naval aviation or the military. "Our passion for naval service and naval aviation is the message we wish to convey to young men and women across our great nation and across the globe," Frosch said. In their 68th year of performing, the Blue Angels are expected to show off their skills for nearly 15 million spectators in 2014.

A World War II veteran and the nation's oldest living Medal of Honor recipient has died in New Jersey. Nicholas Oresko, an Army master sergeant who was badly wounded as he single-handedly took out two enemy bunkers during the Battle of the Bulge in 1945 died at the age of 96. Oresko received the Medal of Honor from President Harry Truman on October 30, 1945. The Bergen Record reported that several veterans and young members of various branches of the military stayed with Oresko in his final days after a friend wrote about his health problems on a Facebook page and noted that Oresko had no immediate family still living.


On Wednesday, March 5 the United States Senate defeated the nomination of Debo Adebile to head the Justice Department's Civil Rights Division.

The Dante Club

Matthew Pearl graduated from University School of Nova Southeastern University. He attended Harvard College and Yale Law School and has taught writing and literature at Emerson College and Harvard University. He lives in Cambridge, Massachusetts.

The book being reviewed in this article, *The Dante Club*, was published in 2003. His second novel, a historical thriller about the death of Edgar Allan Poe called *The Poe Shadow*, was published in 2006 and was a *New York Times* bestseller. His third novel, *The Last Dickens*, was published in the United States in 2009, and his latest novel, *The Technologists*, was published in 2012. He lists his birth date as October 2 but nowhere in public electronic media can be found the year of that birth, which offers a bit of its own mystery.

The novel's setting is Boston, Massachusetts, shortly after the end of the so-called Civil War. The author, Mr. Pearl, very skillfully intertwines historically accurate events and real-life characters with the excitement and fast-pace of a fictitious serial killer.

The poet Henry Wadsworth Longfellow, Dr. Oliver Wendell Holmes, James Russell Lowell and J. T. Fields form a group of intellectuals whose quest is to translate *The Divine Comedy of Dante Alighieri* for the first time in the United States. The poet Longfellow was highly revered at this time, particularly in academic circles. Dr. Holmes was the father of one of the most famous United States Supreme Court Justices who bore his father's name. James R. Lowell was an interesting poet, first trained as lawyer, he became a professor of languages and at one time was the editor of *The Atlantic Monthly*, a magazine still in publication today. The group seems an unlikely bunch of sleuths, and the idea of a classical poem and a group of intellectuals would seem to severely handicap an author trying to write a thriller, but Mr. Pearl excels at deliver-

ing just such a book. Of course, once you become slightly familiar with the first book of *The Divine Comedy*, titled, *The Inferno* you will easily see the possibilities for a writer of violence, murder and intrigue. Today's murder mystery writers have produced nothing to exceed the twisted forms of torture and punishment that a reader will find in *The Inferno*.

Murder victims begin appearing and they strongly resemble characters found in Dante's masterpiece. It is the expertise of the Dante Club members that allows them to recognize what is happening. But they must be very circumspect in their investigation. Harvard University is adamantly opposed to anything written by an Italian Catholic and its distribution to the American public. The New England Protestant elite found it disturbing that many immigrants were arriving on their shores, and their literature was viewed as a corrupting influence. And now a judge, a minister and a wealthy merchant have been horribly tortured and murdered, putting pressure on Boston politicians as well as their police department. A twist in the story line involves the introduction of an African-American police officer, Patrolman Nicholas Rey. Apparently based upon research, there were a few African-American men assigned to the Boston Police Department during this era. They were not issued a firearm and originally were assigned only to African-American neighborhoods. Officer Rey provides a very strong supporting role to the Dante Club as they put their combined intelligence to work to find the murderer.

Hidden in the book is a phrase uttered by Ralph Waldo Emerson that may have been a force behind some of the author's writing: "Without action, the scholar is not yet man. Ideas must work through the bones and arms of good men or they are no better than dreams." These men of letters, with some help of the strength of men of action, do find their man. There is no hint of who that may be for approximately three-fourths of the book. I will

not be giving away much when I say that there were many men wandering about Boston who had fought some hellacious battles just a short time previously. Dante's description of hell certainly could have sounded like a place they had been familiar with, brutal and gory, with little or no compassion being given. *The Dante Club* succeeds on numerous levels: making history come alive, bringing literature to the common reader, all making for a fun mystery.

The Guts

I still haven't figured out how Roddy Doyle had me laughing so often and so hard about a protagonist who has been diagnosed with cancer and uses foul language like it was flowing from a waterfall. Perhaps it is because Mr. Doyle so fully invests himself in his stories and his characters and is, himself, a happy and hilarious person. I have never met the man, but I'm guessing he is a happy soul based upon his collection of ten novels for adults, seven books for children, seven plays and screenplays and dozens of short stories. I also read an interview of him recently and he seems happy. After having received several awards, having three of his novels made into movies, and being described as the Celtic Tiger of Irish Literature, he also seems very modest, plain speaking and a person one would enjoy sharing a beverage with at a local tavern.

Speaking of sharing a beverage at a pub, this novel's protagonist, Jimmy Rabbitte, does a bit of that throughout the story. At one point he proclaims, "Spent the whole day tellin' people I love that I've cancer, and I enjoyed myself." Another time he wants to share his diagnosis with an old friend and attempts to arrange to meet him at a pub: - What's that? he said, I lost yeh there. - About six, said Darren. I'll come in straight after. - Straight after what? - Work. - 'Oh grand, said Jimmy. - You still have a job so. - I have, yeah, said Darren. - I've hidden it. - Good man. (All punctuation here is how it appears in the book and not my creation).

Jimmy Rabbitte is the same fellow readers and moviegoers got to know in 1991 when Mr. Doyle's novel *The Commitments* was made into a well-received movie by the same name. In

1991 Jimmy was a young and ambitious musician trying to put together a rock and roll or soul music band with friends of his from the working-class of Dublin, Ireland. It is now twenty-five years later and Jimmy has had a small amount of success but is no longer young, is married with children and a malignant growth in his "guts." Jimmy and his wife, Aoife, are putting on their best faces to handle their immense problem, but the humor is clearly concealing despair and fear, "He coughed. - It's cancer of the bowel you have, Jimmy, said Aoife. - Not the lungs. - I only f----- coughed. - She sighed. - Sorry. - Grand." Mr. Doyle has always used a lot of dialogue and less narrative description, a talent that few writers can do successfully, and even fewer as successfully as this author. The truth is, however, Roddy Doyle is not an author for all readers. His use of profanity is extreme and he has a very solid understanding of the view of the world held by low-income working class people. Based upon his description of a two-day outside rock concert I concluded that he has a real-world understanding of that bit of chaos as well. The story also describes a life passage between father and son as they try to tell each other how much they care for one another and, later, Jimmy does much the same with his younger son, who is now the outrageous musician in the family. Twice the author uses the expression that people in Jimmy's life were "... trying to get closer without actually moving. Without making a show." In spite of the language, the strange punctuation and grammar and the seemingly out of place humor this is a book about family and about caring for one another. It also made me laugh a great deal and I'm looking forward to more from Mr. Doyle.

CPAB Run!

What do SAFE (Safety Awareness for Everyone) and PERF (Police Executive Research Forum) have in common? Both are non-

profits founded in 1976 and promote best practices in community policing. As an independent research organization that evaluates crime reduction strategies, PERF recommended in 2007 that the SFPD devise a program to strengthen its relationship with the community. In-depth discussions led to the birth of another four-letter acronym, CPAB (Community Police Advisory Board).

District Station Captains choose residents, business owners, and other stakeholders who represent areas of their district. These individuals meet with the Captains on a monthly basis to enhance communication and collaborate on problem-solving. In addition, Captains ask their CPABs to develop crime prevention strategies and to work in the greater community to disseminate a message on public safety. SAFE has co-facilitated these meetings since the first CPAB was piloted at Ingleside station in late 2009. Four years later, CPABs are an integral part of police districts across San Francisco.

On February 24, SAFE hosted a semi-annual Citywide CPAB Summit at the Police Academy. The event, kicked off and supported by Chief Greg Suhr, attracted about 100 members of the Department and civilians combined and celebrated the achievements of this partnership.

During the first segment of the evening, attendees helped themselves to a generous buffet, provided by the Police Captains, and visited the information tables set up by each CPAB. CPAB members hung colorful banners and outfitted their booths with collateral from successful projects, among them:

- “You’ve been mugged” postcards in Taraval, warning the community of the dangers of displaying electronic devices;
- Be City Smart flyers in Southern, educating the community about not leaving valuables in their vehicles;
- Bar coasters with safety messaging in Mission and Northern, an educational tool used to prevent crime;
- The Street Smarts road safety banner campaign in Richmond promoting traffic safety;
- “Don’t leave valuables in your car” stickers from Northern
- Gun Buyback flyers in Ingleside, informing the community about turning in their firearms;
- Bike Registry cards, stickers, and pamphlets from Park to prevent bicycle thefts and increase reporting and recovery;
- Newsletters and branded materials from Tenderloin focusing on crime prevention; and
- An anti-graffiti campaign from Central.

Most of these projects resulted from

a rampant problem in the community. Chicago Mayor Rahm Emanuel got it right when he famously said, “You never let a serious crisis go to waste.... it’s an opportunity to do things you think you could not do before.” Similarly, it came as no surprise that many of these problems are not district-specific, which motivated CPABs and other related organizations, like Castro Community on Patrol, to work together on design, printing, and distribution of nightlife-related safety materials.

CPABs adhere to cooperatively developed guidelines, a nearly 20-page working document that outlines processes, rules, and responsibilities. Despite a shared “constitution,” each CPAB is distinctive in that it reflects the flavor (or often flavors) of its district. When you’ve seen one CPAB, you’ve seen one CPAB.

The second part of the event featured a panel discussion about the state of CPABs four years later. Panelists were Captain Jason Cherniss of Tenderloin Station, Captain Michael Redmond of Southern Station, then-Captain (now Commander) Bob Moser of Mission Station, CPAB co-chairs Mary Harris of the Taraval District and Sean Sullivan of the Park District, and SAFE Program Director Irina Chatsova.

- Topics addressed included:
- CPAB structure (co-chairs, subcommittees, etc.)
 - Diversity in selection and composition of the board
 - Attendance requirements
 - Elements of success in relationship building
 - Challenges that led to innovation
 - Ensuring continuity when Captains change
 - Differences between CPAB and regular community meetings

In the final portion of the evening, attendees split up into three different groups for discussions about burning topics in crime prevention and public safety:

- Pedestrian safety
- Nightlife safety
- Street crime

Staff from the DA’s office, including Neighborhood Prosecutors, joined law enforcement officers in making presentations in their areas of expertise. The Neighborhood Prosecutors have partnered with the Department to address low-level neighborhood crime through community courts. Likewise, the presence of an Assistant District Attorney at the District Station has proved to be a valuable resource for officers and Station Investigations Teams tackling crime in real time.

One of the goals of this Summit was to encourage participants to keep the conversation going. After almost three hours together, audience members continued to linger and share ideas. It’s clear that cooperation and innovation are thriving.

SAFE and the San Francisco Police Department look forward to a continued partnership. We are grateful for our newest crime prevention strategy in the use of Community Police Advisory Boards.

The Hebel Economic Forecast For 2014

Classic Signs Of Economic Recovery Are In Place! Stock Indices Are At All Time Highs! Housing Is On The Rebound! Interest Rates To Slowly Rise!

- Dow Jones Industrial Average 2014 range: 16,500 to 17,925 with many corrections...
- Inflation (CPI): about 2.0 %
- Real growth of domestic production (GDP): growing to 3.5%
- Price of barrel of crude oil: \$95 (average price)
- Average yield on money market funds: continuing below 0.15 %
- Unemployment: edging downward to 6.2 % at year end; although all-inclusive U6 job-less rate is about 13.1% (measure of unemployment/under-employment);
- 30 year fixed rate mortgage: 4.75 % to 5.5% (on conforming loans)
- 10 year treasury notes yield: 3.5 %, rising from near 50 year low
- Interest rate trend: gradual upward adjustments
- Increase in S&P 500 corporate earnings: 9.5%
- Expected average real, total return on equities: 7.5 % to 9% over next 5 years

Most investors may not have recognized it at the time, but March 2009 offered one of the best opportunities for equity appreciation in a lifetime. The United States was in the worst financial crisis and deepest recession since the Great Depression of the 1930s, global stock markets had been in a free fall, credit markets had seized up, and large financial institutions faced total collapse. The S&P 500 (index of large-cap U.S. stocks) had fallen 57% from its peak in October 2007 to its last low on March 9, 2009 marking one of the worst bear markets in U.S.

financial/economic history.

Fast forward to the end of 2013: The U.S. stock market ended last year celebrating a recovery that ranks as one of the longest and greatest bull markets ever. Despite political and economic hurdles, the S&P 500 posted a 29.6% gain (32.4% with reinvested dividends) adding \$3.75 trillion in market value, plus \$312 billion in dividends, for its best year since 1997. Wow! The Dow Jones Industrial Average (popular index of 30 mega-cap U.S. stocks) rang out 2013 up 26.5% (29.7% with reinvested dividends), its best return since 1996. That put the Dow more than 10,000 points above its March 2009 bear-market low. Wow!

2013's stock performance reminds me of the "good old days" of stock investing – namely 1982 through 1999 when the S&P 500 index had a return of 17.9% annualized. And from 1995 through 1999 the returns were even better – at 28.6% annualized. While that era is gone, the surprise given to us by the U.S. equity markets in 2013 is most welcomed. Going forward I will be delighted with an 8% - 10% real annual return in equities over the next 5 or so years. While I can certainly provide no guarantees regarding future returns, I do firmly believe that for those looking back five-to-ten years from now, even from the current levels in the market, this will have proven to be an excellent time to be actively investing.

I frequently look to my investment advisor Warren Buffett, Berkshire Hathaway CEO and arguably the world's best investor of the 20th century, for his wise and sage advice. In a recent annual report to his Berkshire shareholders, he said: "American business will do fine over time. And stocks will do well just as certainly, since their fate is tied to business performance. Periodic setbacks will occur, yes, but investors and managers are in a game that is heavily stacked in their favor. The Dow Jones Industrial advanced from 66 to 11,497 in the twentieth century, a staggering 17,320% increase that materialized despite four costly wars, a Great Depression and many recessions. And don't forget that shareholders received substantial dividends throughout the century as well."

The Hebel maxim:


There is no safe, quick and easy way to build wealth. A firm commitment to a well conceived long term investment strategy using a well diversified portfolio is required to accumulate wealth over time. This endeavor is best viewed as a marathon rather than a 100 yard sprint. Within the context of alternating bull and bear markets, the main long term forces of the market have historically favored the bull.


Dr. Schiller is also well recognized for his influential book *Irrational Exuberance* in which he argues that no mechanical or technical system can be devised to predict stock prices, because behind Wall Street is human behavior, and investors are notoriously emotional in their decision making. He is widely regarded for predicting the top of the stock market in 2000 just before the .com collapse and the real estate market in 2007.

Mike and Gityjoon visited with Dr. Schiller at the November 2013 AAI Investor Conference held in Orlando, Florida. In his keynote address entitled "Understanding Confidence and Bubbles in View of Recent Events", Professor Schiller commented on the dominant role that human psychology plays in producing asset (stocks, real estate) bubbles noting that the U.S. is becoming a more speculative culture with its population still very focused on home prices.

He said that by 2005 there was a "house buying mania" in the U.S. which collapsed (real estate drop of 43% in real terms) over the next several years. (In 2005 Schiller had predicted a 50% drop in real estate prices.)

He did thrill the audience when he said that over the next 10 years the stock market will go higher, but then admonished at a muted 2.5% average annual return.

Wealth and financial security cannot be created with negative rates of return – the current condition of the stable value portfolio. Yet about 37% of all participants' deferred compensation monies (\$972,491,087 in stable value as of 1/31/14) are in this portfolio – now guaranteed, with a 1.2% crediting rate, to generate, when adjusted for inflation, real negative returns. Even the CCSF deferred compensation consultant, Angeles Investment Advisors, commented in its October 9, 2013 report to the Retirement Board: "Because of low crediting rates in the current low interest rate environment, stable value may not keep pace with or exceed inflation over time and therefore may not be the best choice for participants with longer time horizons."

In my judgment short-term interest rates will remain below the rate of inflation for the next several years. With the Stable Value Portfolio reducing its bond duration, it will continue to capture very low rates of return on its underlying portfolio – and can therefore only return to deferred compensation participants very low, after expense, crediting rates. You must earn an effective rate of return on your investments in order to achieve financial security; this cannot be done without taking on some degree of investment risk. I urge you to consider better options for your hard earned money – especially the many Target Date Funds offered in the deferred compensation plan.

The Dow Jones Industrial Average above 16,000: Wall Street Races Ahead While Main Street is stuck in Neutral

Is income inequality, e.g. the Wealthy vs. the economically stressed Middle Class becoming a growing American problem without a viable solution?

Answer: No. But it does help to understand the reasons for America's income inequalities multiple underpinnings.

U.S. Stock Market Record Highs

On 2/28/14, Mr. Ben Levinson, a business writer for Barron's noted;

"The stock market has that non-stop feeling going for it as well. Sure 2013 was a blockbuster by any standards, but even 2014 is looking OK following some early volatility. The S&P 500 gained 4.3% to 1,859.45 in February, closing the month at a record high. That 4.3% gain was the best February performance since 1998. The Dow Jones Industrial Average gain rose 4.0% to 16,321.71 in February, but still finds itself down 1.5% on the year."

The Dow Jones Industrial Average consists of 30 of the nation's leading companies. These companies are listed as follows, based on the February 28, 2014 high of 16,321.71.

On 3/10/14, Mr. Steve Rothwell, an Associated Press Markets writer stated that the American Stock Market celebrated its fifth straight bull market since March 9, 2009. The current bull market run is not the longest, or strongest in history, but it has survived a near default by the United States Government, a debt crisis in Europe, and a war in Syria.

And, despite all of the obstacles thrown in its way, the bull market is now the fourth-longest since 1945, according to S&P Capital IQ. A bull market is a rise of 20 percent or more over a period of at least six (6)



months, following a decline of 20 percent or more. The run-up over the past five (5) years has been helped by stimulus from the Federal Reserve, record corporate profits, the economic recovery and companies repurchasing their own stock.

Flat Middle Class Wages 1980-2014

On 3/7/14, Mr. Christopher S. Rugaber of the Associated Press stated that the Great Recession hammered Americans' net worth, cutting their overall wealth to \$55.6 trillion dollars in the first quarter of 2009. That figure was 19 percent below the pre-recession peak of \$68.8 trillion dollars.

In 2014, United States wealth has since recovered. However, households have not benefitted equally. Much of the American rebound stems from stock market gains. Yet roughly 10 percent of households own about 80 percent of stocks. Most middle-class wealth stems from home ownership, and house prices nationwide remain below the peak reached in the spring of 2006.

Household wealth, or net worth, reflects the value of homes, stocks, bank accounts and other assets minus mortgages, credit cards and other debt. The Federal Reserve noted that household net worth jumped nearly \$3 trillion dollars during last year's fourth quarter to \$80.7 trillion dollars. Stock and mutual fund portfolios gained nearly \$1.7 trillion dollars, or 9 percent. The value of American homes rose just over \$400 trillion

dollars, a 2 percent gain. And check account balances, pension plan assets and retirement savings, such as 401(k)'s, also increased.

On 2/26/14, Richard Larsen, an Associated Press award winning columnist noted the middle class in America is shrinking; numerically in terms of the percentage of the total population, as well as qualitatively in terms of the quality of life. Mr. Larsen stated that many members of the middle class are being squeezed by declining real income and rising expenses, but the middle class is increasingly shouldering the inflationary costs of corporate America, and the burdensome costs of government operations.

Journalist Bill Moyers of the Public Broadcasting Service (PBS) noted the Middle Class is roughly defined as those households ranging in income from \$25,000 to \$76,000. At \$51,017 the real median household income in 2012 is even less than it was at the end of the 1980s, and it is down 9 percent from its high in 1999, with the biggest portion of that decline, 8.3%, in just the past five (5) years. In 1967, the median household middle class income was \$42,934; in 1989, \$51,681; in 1999, \$56,080 and 2012 the median income was \$51,017.

The median net worth of a family in 2010 was \$77,300, compared to \$126,400 just three (3) years earlier. In 46 of our 50 states, the poverty rates have increased over the past five (5) years, and the national poverty rate is over 15% for the fourth (4) year running. The last time that happened was in 1965. Mr. Larsen noted that more and more families are dropping from the ranks of the middle class into poverty.

Mr. Robert B. Reich, former Secretary of Labor under President William Jefferson Clinton and a leading authority on economics who served under Presidents Gerald Ford and Jimmy Carter, in 2013 made a 90-minute documentary on how and why there has been a decline in our country's middle class. In **Inequality for All**, Mr. Reich stated that;

"Some say we couldn't have reversed the consequences of globalization and technological change. Yet the experiences of other nations, like Germany, suggest otherwise. Germany has grown faster than the United States for the last 15 years, and the gains have been more widely spread. While Americans' average hourly pay has risen only 6 percent since 1985, adjusted for inflation, German workers' pay has risen almost 30 percent. At the same time, the top 1 percent of German households now take home about 11 percent of all income—about the same as in 1970. And although in the last months Germany has been hit by the debt crisis of its neighbors, its unemployment is still below where it was when the financial crisis started in 2007. How has Germany

done it? Mainly by focusing like a laser on education (German math scores continue to extend their lead over American), and by maintaining strong labor unions."

It is very clear that the American middle class has suffered from flat wages.

The Entrepreneurial Class

Labor Secretary Robert B. Reich makes it clear that he is no enemy of capitalism and has no problem with the amount of inequality that is inevitable if we are to incentivize behavior. But Professor Reich also takes care to point out that there really is no such thing as a free market. He adds that there are always rules, and the question is, whom do these rules benefit, whom do they hurt, and why did they begin to shift over the past 30 years?

On 2/24/14, Mr. Reich noted that Facebook has agreed to buy WhatsApp for \$19 billion dollars. Secretary Reich said, "If you ever wonder what's fueling American's staggering inequality, ponder Facebook's acquisition of the mobile messaging company WhatsApp."

WhatsApp's worldwide usage has more than doubled in the past nine months, to 450 million people—and it is growing by around a million users every day. Mr. Reich said on December 31, 2013, WhatsApp handled 54 billion messages (making its service more popular than Twitter, now valued at about \$30 billion dollars). WhatsApp's fifty-five employees are now enormously rich. Its two founders are now billionaires. And, the partners of the venture capital firm that financed it have also reaped a fortune.

Professor Reich says that Americans are winners in a sense that we have an even more efficient way to connect with each other. But we are not getting more jobs. In the emerging economy, there is no longer any correlation between the size of a customer base and the number of employees necessary to serve them.

Meanwhile, the ranks of postal workers, call-center operators, telephone installers, the people who lay and service miles of cable, and the millions of other communication workers, are dwindling—just as retail workers are succumbing to Amazon, office clerks and secretaries to Microsoft, and librarians and encyclopedia editors to Google.

Mr. Reich stated that productivity keeps growing, as do corporate profits. However, jobs and wages are not growing. The economist noted that unless we figure out how to bring all of them back into line—or spread the gains more widely—our economy cannot generate enough demand to sustain itself, and our society cannot maintain enough cohesion to keep us together. In short, Wall Street races ahead while Main Street is stuck in neutral.

2014 Philippine Exchange Training Team Returns after Successful Trip

To understand P.E.T (Philippine Exchange Training Team) Lt. Caturday (present) conceived the idea in April of 1999, along with six members of the San Francisco Police Department in establishing an exchange training program with the Philippine National Police.

The Department had already conducted visits with other international law enforcement agencies in the past that included Japan, Russia and Amsterdam. However these visits consisted of semi formal courtesy calls or observing specific enforcement activities then a short written report upon their return.

Eric Quema (retired Lt. SFPD) took the reins and ran with the program until this very day, whose primary mission is to present, discuss and share best practices and current trends in policing with members of the PNP; in the hopes of better serving our respective communities. Outreach to business, community groups and youths complete the circle of true community policing.

The six officers formed the Philippine Exchange Training (P.E.T.) Team, and began the groundwork to build a bridge between the SFPD and the PNP. Their efforts became a reality in the year 2000. It has grown to be a comprehensive exchange training program that has now reached out and included presentations to key business groups, neighborhood-based force multipliers, schools and even to the Philippine Hall of Congress.

Completely self-funded by Team members, the program delivers boxes of material donations to police stations, schools and neighborhood

Training and Education.

The most recent team for 2014 consisted of a 20 member multi-agency team was composed of members from the San Francisco Police Department, BART Police Department, Salinas Police Department, Capitola Police Department, Los Angeles Police Department, SF State University PD, and the California Department of Justice Investigations Department.

The subject matter covered: first responders to critical incidents, basic



officer safety considerations, weapon retention and defensive tactics, investigation techniques, bike patrol, emergency carry evacuation, community policing, personal safety, ethics and leadership.

Presentations were also made to business groups, an orphanage, elementary and high school students and a senior citizens center.

Topics covered were site security measures, relationship with police, peer pressure, bullying, anti-drug messages and good citizenship.

Over a hundred balikbayan boxes full of school supplies, office supplies, police gear, basic life support and health information, clothing, toys, books, mountain bikes, police souvenirs, public safety giveaways, mini-disaster kits, backpacks and computers were donated during the course of the trip. Due to the volume of items collected, donated and even purchased by

individual team members we were able to make surprise unscheduled stops at an additional elementary school,

a senior citizen center and an additional police facility. The total value of all donated items is estimated at around \$10,000-\$15,000 plus U.S. dollars.

The highlight of this trip, was the donation of cash to families in the provinces of Leyte, Tacloban by Officer Ray Padmore. What initially started with a donation by Sgt. Omar Bueno (ret.) quickly rose to \$2800. The average starting pay for Philippine Na-

tional Police Officers is approximately \$500 a month. The current force of first responder Officers assigned to Leyte is approximately 290, of which only 54 attended work during the recent, record breaking devastating Typhoon that hit the Philippines. Seven (7) PNP families hit the hardest were selected for a cash donation of \$100 each. Extra donations received by Organizations and PET Team members enable Officer Padmore to donate to 28 families. Most of these families lost relatives, spouses, children and other loved ones. Although no amount of cash can bring a loved one, the appreciation was obviously visible by the "tears" displayed by our fellow law enforcers of the Philippine National Police.

Since the return of the Team, additional donations continue to come in to FALEO, who in turn insures that funds are used and specifically earmarked for the Victims/Families of Typhoon Haiyun.

The PET team wishes to acknowledge and thank the following supporters for making this trip so successful.

Great Quake of 1906 Kills SF Officer

Synopsis of the San Francisco Police and Municipal records of the "Greatest Catastrophe in American History"

April 18th marks the 108th anniversary of the "Great Quake" of 1906. San Francisco Police Captain Thomas Duke was charged with the task of recapping the destruction, heroics, and resources in a report to the Police Commission. The report is a fascinating look back at this watershed event in SF history. In it, Captain Duke writes about:

- SF police officers orders to seize and remove all food from grocery stores to prevent a famine riot,
- The order from the Mayor that officers shoot and kill looters,
- The death of the city's fire chief,
- The use of Central Police Station's pistol range as a temporary morgue,
- The "temporary" burial of dead bodies in Portsmouth Square Park – including the remains of Officer Max Fenner, the only on-duty police officer killed in the earthquake.

This is a glimpse into the past, and the chaos that was aptly handled by the SFPD. As Captain Duke wrote, "A volume would be required to record the many heroic deeds performed by the firemen and police during those three eventful days and nights."

As this great disaster has been the theme of numerous able historians, the main events will be but briefly dealt with, and we will then pass to the events known only to those who for three days and nights battled "amid the crash and roar of the burning city," constantly risking their lives to rescue others and to procure provisions from burning stores in order to prevent a famine.

The great earthquake occurred at 5:14 a. m., April 18, 1906. As the shock shattered the principal water mains, the fire department was practically helpless and as a result, the fires which were started by the overturning of stoves, crossing of electric wires, the liberation of chemicals by breakage of containers, etc., rapidly spread until a territory of 4.7 square miles in the heart of the city was burned, and a loss approximately estimated at \$275,000,000 was incurred.

The City Hall was a mass of ruins after the earthquake, so Mayor E. E. Schmitz proceeded to the Hall of Justice, where his first orders were issued.

As the earthquake rendered the jails unsafe, he ordered that all petty offenders be released, while those charged with more serious offenses were sent to San Quentin State Prison.

Reports reached headquarters that thieves were burglarizing wrecked stores and deserted homes, and it was also learned that in the Mission district the body of a woman was found, the finger upon which she wore several valuable rings having been amputated, evidently by some thief.

The next report was to the effect that rowdies were breaking into saloons and helping themselves to liquor.

As the police were busy conveying

the wounded to the temporary hospitals and had no time to arrest thieves even if caught in the act, and no place to incarcerate them if arrested, the Mayor issued his first order to Chief Dinan under the "law of necessity," which was substantially as follows:

"Apr. 18, 1906.

"As it has come to my attention at thieves are taking advantage of the present deplorable conditions and are plying their nefarious vocations among the ruins in our city, all peace officers are ordered to instantly kill any one caught looting or committing any other serious crimes.

"E. E. SCHMITZ, Mayor."

About 8 a. m. Brigadier General Frederick Funston, U. S. A., called at the Hall of Justice, and after a conference with Mayor Schmitz, he placed his troops at the disposal of the Mayor. From that time until conditions became normal, the soldiers worked in conjunction with the police, either in preserving order or distributing provisions.

Shortly after the troops began patrolling the streets the first looter was caught while he was making an attempt to burglarize Shreve's jewelry store at Post and Grant avenue. He was turned over to a soldier who killed him and left his body to be consumed by the fire.

The Morgue, which was only constructed for ordinary occasions, was soon filled to overflowing with the bodies of victims of falling walls, etc., so the target range of the Central Police Station was turned into an emergency Morgue for the time being. But as the fire was rapidly approaching that building, the twenty-eight bodies placed there were temporarily buried in Portsmouth Square.

Of the 478 bodies finally recovered a great number were unrecognizable because of their mangled condition. It will never be known how many were killed, as the heat of the fire was so intense that the bodies were reduced to ashes in many instances, but judging from reports of persons missing and other circumstances, the number has been estimated at between 1,000 and 1,500.

On Third street near Mission, a building collapsed in such a manner as to pinion an unknown man to the ground. His cries attracted people on the street, who attempted to rescue him, but at that time the fire had reached the rear end of the building. Realizing that he would soon be burned to death he begged the bystanders to kill him. After some hesitancy, a large, middle-aged man stepped forward, and after a few words with the unfortunate prisoner, he whipped out a revolver and shot him through the head, killing him instantly. He then requested the witnesses to accompany him to the Hall of Justice, where the Mayor, who after hearing the circumstances and seeing the man's distressed appearance, commended him for his humane act.

Among those killed was Dennis Sullivan, the able Chief of the Fire Department, who was asleep in his room at the Engine House adjoining the California Hotel on Bush street.

The engine house was a two-story structure and a massive brick chimney fell from the top of the eight-story ho-

tel crashed through the engine house roof and struck the Chief. He was removed to the Presidio Hospital, where he died on April 22.

The greatest damage done by the fire was in the Harbor Police district, commanded by Captain John Martin; the Southern district, commanded by Captain Henry Colby; the Central Police district commanded by Captain Thomas Duke and the Mission district, commanded by Captain M. O. Anderson.

As it seemed that the fire would sweep the entire city, about 200,000 panic stricken people took advantage of the free transportation furnished by President Harriman of the Southern Pacific Railroad and left the city. Another hundred thousand, who lost their homes, camped in the public parks and graveyards, many gladly taking advantage of the shelter afforded by the vaults for the dead, especially during the rainstorm beginning on April 23. Because of this storm the police took possession of all vacant buildings and placed as many families in each as the building could comfortably hold. It is estimated that about 2,000 families were provided for in this manner.

On the morning of the earthquake it became apparent that immediate steps must be taken to prevent a famine. Police officers were therefore detailed to seize all suitable conveyances and remove the contents of all grocery stores which were in danger of being burned. This work was kept up for three days and nights, and as a result the contents of 390 grocery stores were delivered to the refugees.

On April 19 it was learned that several large ships, which had been heavily loaded with provisions previous to the disaster, were about to leave for foreign ports. To prevent this a police guard was placed on board the vessels, and as an extra precaution Lieutenant Frederick Green was instructed to procure the tug "Sea Rover." With a squad of eight officers on board this vessel, the exit from the harbor was blockaded from April 19 to 24 inclusive. By this time provisions were arriving by the trainload and the danger of a famine had passed.

For many weeks after the earthquake all saloons in the unburned district were kept closed by order of the Mayor. In some instances a disposition was shown to ignore this order, and the result was that every ounce of liquor in the establishment was turned into the sewer.

When it became apparent that the Hall of Justice would be destroyed by fire, all valuable police records were removed to Portsmouth Square and left in charge of a detail of officers, consisting of Detectives Charles Taylor,

George McMahon and others. These officers were provided with provisions but no water was obtainable. The fire rapidly surrounded the square and the officers became prisoners. The heat was terrific and the cinders, which were falling like hail, were constantly igniting the canvas spread over the records. As there was a saloon across the street which had not at that time caught fire, a raid was made on the place, and for the next twenty-four hours bottled beer was used to keep the canvas from igniting, and thus the records were saved.

Several insane patients were confined in the Receiving Hospital in the City Hall building on the morning of the earthquake, and when the building began to rock and the walls began to fall, their condition can be better imagined than described. Officer Frank Parquette made his way through the wreckage to their rescue, and by the use of much tact succeeded in getting them into the Mechanics' Pavilion, which was utilized as a general hospital, until the fire drew near.

Patrolman Max Fenner, known as the Hercules of the Police Department, was standing opposite the Essex Lodging House, a seven-story brick building on Mason near Ellis street, when the earthquake occurred. He observed that the front wall of the building was tottering and at the same time he saw a woman run out of the building onto the sidewalk. He tried to warn her of her danger, but as she did not move he rushed over toward her. Just then the whole front of the building fell out, and while the woman ran inside the doorway and was unharmed, Fenner was instantly killed and his mangled body was buried in Portsmouth Square until the fire subsided.

As has been previously stated, no water was available for fire-fighting purposes, so dynamiting squads were operating near the fire line under the supervision of the army and police officials. By the use of this explosive great structures were leveled to the ground for the purpose of checking the fire. Captain of Police Henry Gleeson and Lieutenant Charles C. Pulis, U. S. A., were in command of a detail on Sixth Street. They had placed a heavy charge in a building located on Sixth street near Market and lit the fuse. This burned much more rapidly than expected, and before the officers could escape the explosion occurred and they were blown out into the street, where considerable wreckage from the building fell upon them. Both men were rendered unconscious. They were removed to the temporary hospital at the Mechanics' Pavilion, thence to the Presidio Hospital, where they eventually recovered.

During the height of the conflagration, Officer Edward Leonard, accompanied Deputy L. K. Jones into the City Tax Collector's office in the ruins of the City Hall, and records were saved which enabled Tax Collector J. F. Nichols to collect over \$1,000,000 in taxes.

A volume would be required to record the many heroic deeds performed by the firemen and police during those three eventful days and nights. And it must be remembered that the majority of them labored with little nourishment and no sleep, and with

the knowledge that their homes were destroyed and the fate of their families unknown. Officer James Connolly had concluded that his entire family had been killed, but a week later he located them in Vallejo, Cal.

On the evening of April 19, Officer T. Flood was about to enter his home at 1722 Hyde street with the intention of saving some articles from the fire which was fast approaching. The officer's uniform was burned and he was in civilian clothes. Just as he was about to go up his front stairs, two men came out of the front door. Flood demanded that the strangers state what business they had there, but the only answer he received was a blow on the jaw which knocked him down. Flood's assailant then kicked him on the side of the head, splitting his ear. The officer drew his revolver and killed him but the other man escaped. The body was taken to Portsmouth Square for temporary burial, but the dead man's identity was never learned.

As there were only a very few pipes in the city from which water could be obtained for many days after the fire, it was distributed for cooking purposes by means of the street sprinkling wagons.

For several days after the earthquake the city was in absolute darkness at night time, as no lights were permitted in houses; but on April 22 Mayor Schmitz issued the following order:

"Lights are permitted in houses between Sunset and 10 p. m. only, unless sentinels are convinced that some latitude should be allowed in case of sickness.

"As all chimneys were more or less injured by the earthquake, no fires will be permitted in houses in grates, stoves or fireplaces unless the occupants hold a certificate issued by an authorized chimney inspector. Said certificate to be

posted in a conspicuous place in front of the building.

"The importance of this provision is emphasized by the fact that no effective means are at hand for stopping fires.

"Our greatest danger in the immediate future may be expected from unavoidable unsanitary conditions and every person is cautioned that to violate in the slightest degree the instructions from the officers will be a crime that cannot be adequately punished,.

"All persons, except suspicious characters, will be permitted to pass sentinels without interruption.

"E. E. SCHMITZ, Mayor."

The order prohibiting persons from building fires in houses resulted in all kitchen stoves being moved into the street, where cooking was done for many weeks.

After the fire the streets in the burned district were covered with debris, and instructions were issued to force all idle and dissolute men to assist in clearing the streets.

On April 26, Major-General Greely, U. S. A., General Koster, of the National Guard, and Mayor Schmitz entered into an agreement to the effect that the regular soldiers should police one-third of the city, the National Guard one-third and the regular police one-third. This continued for some weeks until the police took complete control. The regular army also had charge of the distribution of all food and clothing shipped to San Francisco for relief purposes.

Choosing a Personal Trainer
