### President's Message

## Tough Calls for Tough Times

San Francisco may be a lot of things but for better or worse it's never boring. I write this article after learning that Chief Heather Fong will be stepping down early this year.

That news came on the heels of being summoned to the mayor's office this past week to be given a first-hand account of the dire economic crisis that confronts our city.

You would have to be brain dead not to comprehend the fact that our

country is facing a situation we have not seen since the Great Depression. Massive layoffs, double digit unemployment, a record number of foreclosures and bank failures, and even the possibility of the American auto industry going under should signal to all of us these are not normal times.

Locally, we will see many more layoffs and business failures in 2009. It will certainly be a bloody year for local business. Our own members have seen their deferred compensation accounts shrink by as much as 50% while many more of our members are struggling to


stay in their homes as a result of the mortgage crisis.

What we do have that most Americans do not is job security and a comfortable pension that we can count on when we retire. Americans that are solely dependent on their savings and 401(k) accounts must completely readjust their retirement plans based on the crumbling economy. We also have a contract that we were able to negotiate prior to the roof caving in and have already realized several raises as a result. We must now decide collectively what our obligation may be, if any, to help the city of San Francisco through this economic crisis. We must consider ways we may help without putting our own members into economic crisis.

Personally, I believe we should do our part for two very important reasons:

1. It is vitally important to maintain a positive and healthy relationship with City Hall because these are the same people with whom we will negotiate in 2011.
2. We have a responsibility to other city workers to help minimize the inevitable layoffs that will occur in the coming year.

We have been very fortunate over the past decade to realize unprecedented wage increases and enhanced pension benefits. We have been en-

titled to each of those gains just as we are entitled to our current, and future negotiated, wage increases. But tough times call for everyone to make concessions. I am committed to protecting our contract, and our raises, while at the same time exploring ways in which we can help the city get through these next couple of years.

In the past I have questioned the reality of the city's claims of economic hardship but I believe that this time the problems are real and we as an association have some very difficult decisions to make. I will keep the members informed on the situation through your representatives and bulletins. We have been here before and we will make prudent, intelligent decisions that protect our members and at the same time work with the city to minimize the potential catastrophic effects of the current fiscal crisis.

## Three SFPD Officers Suffer Serious Injuries in Traffic Collisions

### Solo Officers Injured During Toy Escort Detail

Two Solo Motorcycle Officers suffered serious injuries while participating in a Toy Drive escort detail. The officers lost control of their motorcycles on a wet and slippery street and collided with a parked car.

Officer Felix Sung, the Solo assigned to Co. B, is still recuperating in the ICU at SFGH. He sustained life-threatening injuries, including a broken neck and severe facial injuries. Officer John Anton broke his wrist in an effort to deflect Officer Sung away from the parked vehicle.

In an unrelated collision, Officer Hans Gumpfer of Ingleside Station was seriously injured while pursuing a suspected 245 felony suspect on foot. Officer Gumpfer was struck by a responding radio car in the area of Geneva and Mission Streets. He suffered several bone fractures and was transported to SFGH.

## Chief Fong to Retire in April 2009

San Francisco Police Chief Heather Fong, who rose through the ranks to become the city's first female chief nearly five years ago, announced that she would retire in April of 2009. She made the announcement on December 20. The chief also said that she would assist Mayor Gavin Newsom in a "nation-wide" search for her replacement. She added that she hopes the next chief will be promoted from within the department, but the decision on who gets the job will be up to the mayor and the Police Commission.

Fong also said the timing to begin her exit is appropriate, given that about a half-dozen reports on how to improve the department have recently been completed or will be soon. The studies cover such topics as foot patrols, station boundaries, technology, racial profiling and how the staff is organized and managed. "I would like to set the course, begin implementation of therecommendations and then turn the department over to others," Fong said.

# POA Board of Directors Meeting, December 10, 2008\*

- Sergeant-At-Arms Breen called the meeting to order at 1210 hours and led the Pledge of Allegiance.
- Secretary Montoya conducted the roll of the Board of Directors and Executive Board.
- POA Webmaster Alex Durouv gave a presentation on how to vote online. The POA Bylaws require all future voting be conducted online.
- Representative Browne (Co. A) made a motion to accept the November 2008 minutes. Motion was seconded by Representative Goldsborough (Co H) and passed by voice vote.
- Sergeant-At-Arms Breen will chair a committee that will discuss the current fiscal status of the City. Committee members are Peter Dacre (Co F), Ed Browne (Co A), Matt Castagnola (Mounted) and Gary Delagnes (POA).
- The status of the 1998 Q-35 list is still being discussed by the Plaintiff's Attorney (Public Advocates) and the City.
- Treasurer Halloran gave a presentation regarding the 2009 budget. As presented, the proposed 2009 budget is \$2,583,700.00. The 2008 budget was \$2,889,200.00 and projected spending through December 2008 is \$2,682,448.03. The 2008 budget will be \$206,751.97 under budget.
- Representative Rosko (Co A) made a motion that the POA establish a rotation process regarding gym equipment for each of the represented units. Four units will receive a maximum of \$2,500.00 per year to purchase gym equipment. Motion was seconded by Representative Donati (Co I) and passed by voice vote.



*Counselor's Corner***"To Hear the Distant Hoofbeat of the Horse of History"**By John Tennant

I must confess to struggling over what to write this month. It's the New Year and a good time for a survey of recent case law interpreting the Public Safety Officers' Procedural Bill of Rights Act — something I have been meaning to do for months. But unfortunately, the magnitude of the economic situation keeps intruding in a way that makes everything else seem almost irrelevant by comparison. How can one not address the larger events in the economy that have led to a whopping \$575 million deficit projected for San Francisco next fiscal year and a deficit ranging from between \$59 and \$65 million for San Jose? Governor Arnold Schwarzenegger has called it a "Financial Armageddon" for the state budget.

And yet, what is there to say? Turn on the cable news shows and you will see scores of economists, market analysts, financial experts, and the like, all pontificating endlessly on their infinitely varied perspectives as to where the economy is heading. On the political side, those in office and those about to take office have offered their opinions on how to turn the economy around, but nothing to date seems to have worked or to be inspiring much confidence. How can anyone, myself included, speak with any authority on the future of the economy?

"Political genius consists in the ability to hear the distant hoofbeat

of the horse of history — and then by superhuman effort to leap and catch the horseman by the coat-tails." This was the great theorist Isaiah Berlin's observation, taken from the nineteenth century German leader Bismarck, on what makes for a truly remarkable leader along the lines of a Churchill or an FDR, someone whose example and inspiration we crave at an historical moment strikingly similar to Roosevelt's time.

And, following this line of thought, the task for anyone aspiring to political greatness is, today, to discern the hoofbeat of whatever forces drive the economy and then to harness them to our own purpose. Now I am certainly no economist, nor anything approaching a statesman, but I can summarize for you the competing narratives in our particular domain — police wages and benefits — that have been offered up by those who think they have heard the hoofbeat of economic history in the context of police labor.

One narrative goes as follows: Police officers and their unions have enjoyed unprecedented successes over the past fifteen years or so. They are among the highest paid of any public employees and they enjoy retirement benefits that are the envy of workers everywhere, whether in the public or the private sector. Indeed, these successes are part of the reason why local governments have been brought nearly to their knees financially — witness the bankruptcy of Vallejo. If anything, the wages and benefits of police officers should be brought more in line with economic reality. The pendulum needs to swing back in the other direction. (For my officer clients in San Jose,

some version of the above narrative will be part of the City's case at the upcoming interest arbitration. For my officer clients in San Francisco, some portion of the above narrative will be part of the City's call for us to forego already negotiated wage increases. Mark my words.)

But there is another, rival narrative competing as a potential candidate for the true hoofbeat of economic history regarding police wages and benefits. This narrative goes as follows: While the earning power of police officers has increased, including pensions, this was dictated by the stark reality of the labor market in light of a nationwide crisis in police recruitment and staffing. No economic development thus far indicates that that crisis is in any way abating for those agencies who cannot meet the prevailing market levels for wages and benefits. Moreover, both state and local government squandered the enormous market gains that had accrued in their pension systems during the boom years through lavish spending rather than continuing needed contributions in the event of a rainy day. And now it is certainly raining. Public employers have only themselves to blame for their current predicament.

An even more sinister variation on the above theme would posit that public employers are using the current financial unrest to, at best, extract unjust concessions from public sector workers that would be unthinkable in not-so-lean times and, at worst, to discredit or even "bust" public sector unions. I wrote a couple of months ago that it would be irresponsible for either management or labor to seize upon the

present crisis as an excuse to overreach, beyond what is fair and reasonable, in such economic turbulence.

For my own part, I do not subscribe to the last narrative — at least as concerns San Jose or San Francisco. The economic problems are real and need to be addressed by all who would claim to be responsible actors on the local economic stage. But such an observation is not an admission that the realities of the labor market must be or should be ignored. While some predict that the troubled economy will soon result in a flood of entry-level applicants to the formerly vacant academy classes and police recruit positions, I am not so certain. I fear that any glaring market inequity in police wages or benefits will continue to prove problematic, lean times notwithstanding. Police work simply does not have the same level of cachet for today's younger generation as it did for previous generations. In working together with our management counterparts to address the financial difficulties facing local government, we cannot ignore that present fact of life.

All of us — political leaders, economic professionals, labor leaders, ordinary citizens — are attempting to put our collective ear to the ground to discern Berlin's "distant hoofbeat of the horse of history." Whoever accurately discerns that sound and, subsequently, successfully "leaps and catches the horseman by the coat-tails" will, indeed, be the modern-day equivalent of a Churchill or an FDR.



# This & That ...

## Speedy Recovery...

On Sunday, December 7, 2008 at approximately 1030 hours, Officer Felix Sung (Co. B- Motorcycle Officer) and Officer John Anton (Co. J- Motorcycle Officer) were involved in a terrible motorcycle accident. The accident left Officer Sung in very critical condition. Officer Anton suffered a fractured left wrist along with other assorted bumps, bruises, scrapes and cuts. The two officers were part of a motorcycle escort provided by the Solos for a charity toy collection effort. The investigation into the accident continues, but by all accounts, we are extremely fortunate that Officer Sung is alive and with us today, and that Officer Anton is anticipated to have a full recovery.

I received a phone call shortly after the accident from Officer Matt Goodin who informed me of the accident and advised me of the seriousness of the Officers' injuries.

I responded to the hospital and met POA Treasurer Marty Halloran who gave me an update on the condition of the officers.

It's true that bad news travels fast because in no time the emergency room was flooded with cops concerned about their fellow officers.

Greg Neal, Felix's partner and very good friend arrived at the hospital and immediately met with and consoled the family of Felix. Lt. Dan Gardner made sure that John Anton's family was taken care of and that anything they needed would be immediately provided.

Chief Heather Fong arrived at the hospital and spent considerable time with both families attending to their needs. Captain Rich Corriea was also on scene and was handling communications with Police Operations and other involved units and details.

Fortunately after several hours, Officer Anton was released from the hospital to the care of his loving family. I was with John for a considerable amount of time that day, and his greatest concern was the condition of his fellow officer. It should certainly be noted right here and now that Officer Anton made an incredibly valiant effort to keep Officer Sung from violently impacting the parked car.

Officer Anton, tried to grab Officer Sung as Felix was propelled through the air and heading towards the direction of the aforementioned parked car. John's effort was superhuman as he immediately had the presence of mind to think and react to the situation that had just unfolded in front of his eyes. Those of us who know John, however, are very familiar with his amazing athletic abilities. (John was a two-time All-American soccer player for outstanding USF teams. John went on to play professional soccer and for many years was an outstanding soccer player with the SFPD soccer teams).

John was overcome with grief as he was consumed with concern over Felix never once complaining about or even acknowledging his own very close call and subsequent injuries. There can be no question that John is a "stand-up guy."

As news of the accident spread throughout the department, more and more officers responded to SFGH with an outpouring of concern for the injured officers and their families.

Both John and Felix are extraordi-

nary men. John is an 18-year veteran of this department and has served in a variety of assignments throughout his career. A very popular and gregarious individual of many talents, John is first and foremost a family man tremendously devoted to his wife and children. A very accomplished athlete (soccer), John is also a very talented musician as seen and heard while he played harmonica and percussion for that once highly renowned San Francisco garage band, RWS.

Felix on the other hand is very quiet and unassuming. He is a graduated member of the 180th SFPD Academy Class, joining the department in June of 1995. He is a very popular member of Southern Station where he has served for the past several years. Felix is known for his infectious smile and quiet demeanor. He is an outstanding and very professional Police Officer. Felix takes great pride in his work ethic and quiet but effective way of handling himself. Felix, like John, is also a very devoted family man. There can be no question of his love for his family, or his family's love for him.

I have worked at Southern Station for the past several years with Felix and I have known John for at least as long a time. I have great admiration for both men, and was very distressed when I was first made aware of the accident.

Since the accident, Officer Felix Sung has made remarkable progress and his condition has been downgraded to serious. He has undergone surgery for his neck and is scheduled for more surgeries. The road to recovery will be a long and arduous one for Felix, but those who know him have no doubt that he will be fighter all the way and will work extremely hard in his recovery.


The doctors, nurses and staff at SFGH have been nothing short of remarkable. Anyone of us who has been around knows that Felix and John are/were treated by the very, very best and are in the finest trauma center in the country. Our deepest thanks and appreciation go out to anybody and everybody who are involved in the care and recovery of our two brothers.

Of course in situations such as this people step up without even being asked. Many officers from Southern Station are involved in the safety and security of Felix and his family, and everybody wants to be a part of the process. Joel Babbs, Nelson Ramos, and Carl Bryant are just three of the frequent flyers to the hospital.

Members from other stations have also been tremendously valuable in the efforts to take care of the family.

On the Monday night after the accident the Sung family needed transportation and with just one phone call to Sgt. Rene Pagano of Taraval Station she set the wheels in motion and in no time Officers Jose Guardado and Juan Gala answered the call and had everything under control. That same night, Sgt. Henry Yee and Officer Deborah Anderson of Southern Station took it upon themselves to go out and get a television and DVD player for the family as they will be spending an extraordinary amount of time at the hospital and in the Consulting Room of the ICU where Felix is being treated.

On Tuesday Night, the "Gentle Giant" himself, Kelly Wesley visited with the family and then went out and brought back dinner from Bucca



Di Beppo Italian Restaurant where Assistant General Manager Efraim Corretjer made sure the family was well "taken care of." Our very special thanks to Efraim and the great folks over at Bucca's who have been good friends of the department for quite some time.

The Sung Family has been hit with a terrible tragedy, but they have been incredibly gracious to all the officers who have responded in some way. Felix's sister has been keeping a log with the names of every officer that comes to visit at the hospital so she can show him when he is able.

The Sung Family has also asked me to thank each and every officer who has visited the hospital or left a message of hope and good will for the family.

Please keep Felix and his family as well as John and his family in your thoughts and prayers. This will be a long process for the families and they will need our continued support.

We sat down one night and discussed the dinner and all that was involved with pulling this little caper off. Ellen Marie was just great with her suggestions as to what should be served and how it should be prepared. She also provided the recipes for the entire meal, from the hors d'oeuvre's to the deserts. They all seemed to be as excited about us being there as we were being with them on this special day (but more about that later). The food and beverages were served much to the great delight of the people who were treated to a truly outstanding meal, which included the mouth-watering appetizers consisting of stuffed mushrooms and melted cheese baguettes. The main meal included a roasted turkey and a big baked ham, mashed potatoes and gravy, sweet potatoes; string beans with sautéed almonds, cranberries and tossed green salad. The beverages were sparkling cider, a home made sparkling punch, and white wine for the adults. And of course for desert...home made pumpkin and apple pies.

The meal was a tremendous success thanks to the many people noted above. Each person contributed a vital part to the final product and the residents of Family House were just so pleased and grateful. I really don't know who had a better time, the folks of Family House who ate the meal or the people who prepared the meal. Either way, that day was just the best.

Of the many memorable moments of the day, the most special was when we met little Madison. Madison or "Maddy" is a six-year old beautiful girl who is battling a tough bout with cancer. When we first met Maddy, she was wearing fairy wings that she could make flap back and forth. She was just a precious sight to behold...a fragile child, yet one who was so engaging and friendly. We all took such joy in spending time with Maddy, but it was Caitlyn Cadigan who made the biggest impression on Maddy. They took to each other like long lost friends and before long the two were inseparable. They spent time making arts and craft items, watching television, and gener-

ally just hanging out. Madison's mom, Keri, was very touched by all the special attention her daughter was getting and for good reason. Madison has been through quite an ordeal that continues on a daily basis, which often includes extended chemotherapy treatments that take quite a toll on her body. Keri told me at one point that she was actually regretting the Thanksgiving Holiday as she and her daughter would be away from her family and friends, but because of the efforts of the POA her spirits had been tremendously lifted and she was having a great day. One she could truly be thankful for.

At one point in the evening, Pat Cadigan approached me and told me that Madison was a big fan of fish and wanted to go to a place where there were "lots of fish." When Keri was told of the Steinhart Aquarium she responded that she knew of the aquarium but because of Madison's weakening immune system she could not be exposed to large groups of people for an extended period of time.

Pat was hoping that something could be done in an attempt to grant this young girl her wish. Again, enter Steve Johnson who, upon hearing this story, made a phone call to Matt Castagnola of the Mounted Unit who was asked if he knew anyone connected to the aquarium that could help out. Similar calls were directed to Captain Rich Corriea and Eddy Wu of Richmond Station for their assistance. Soon, our efforts paid off as we made contact with Mr. John Lewis who is the Director of Security for the Academy of Sciences in Golden Gate Park. Mr. Lewis came through big time and set up a special tour for Madison and her family.

On Friday December 5, 2008 Pat and Caitlyn Cadigan and I met Madison, her sister Shannon, her mother Keri and her grandmother at Family House. Madison was presented with an official SFPD uniform shirt with her name embroidered on it, along with an official police hat. We transported the family to the Academy of Sciences for a very special day. We all had a fantastic time looking at all the fish

and checking out the penguins. We had our own personal tour guide that gave us a great tour where we were able to see so much...including watching a young girl's wish come true.

After the tour, we were met by Matt Castagnola and Carol Scatena (Tac/Mounted Unit) who spent some special time with both Madison and Shannon showing the young girls their horses and even taking pictures with the girls sitting atop the horses. Matt and Carol presented the girls with coloring books and stickers. Matt gave Madison the very special gift of a horseshoe all shined up for good luck!

Shortly thereafter, it was time to get Maddy and her family back home as she was growing tired and needed to get some rest.

I am very grateful to have been a small part of a great experience that included so many people and a little girl with as big a heart as you could ever find. I am so thankful to all the people who were involved in this project from

month.

The UCSF visits have always been a popular event and the December visit was no exception. I am extremely grateful to each and every one of the above listed officers for their great efforts and tremendous dedication to a great calling, helping children...sick children. It is not often an easy task to see and be among some very sick and infirmed children only because it is so sad and brings to light the reality of illness and disease to the most vulnerable of our society, our children. Still we forge on with our monthly visits with the hope that we can bring some joy into some very fragile lives. It can sometimes be a difficult experience but it is always rewarding.

# Close Encounters

Close Encounters

The Police Executive Research Forum (PERF) representatives appeared before the Police Commission the other night. These are the individuals who were hired to tell our Department hierarchy where changes should be made to improve service to the public. And, to PERF's credit, they hammered home the obvious — as socially unacceptable as doing so might be.

They basically told the Police Commission that they have to remember that San Francisco Police Officers cannot repair the city's educational system; San Francisco Police Officers cannot cure addiction; and, most importantly, San Francisco Police Officers cannot resolve all of the problems involving personal relationships within family structures that lead to other activities that involve a police response. (Translation: San Francisco Police Officers are at the mercy of other social agencies who need to pick up the pace.)

The PERF people were also quite appalled at the Department's alleged 'discipline system.' Hello? We've been complaining about decisions not being made for years now and nothing has been done about it. Politicians in the City have to ask themselves if there ever really was any benefit for the public from the passage of Proposition H (where the Police Commission was re-structured) — doesn't appear to be any.

And, while we are in the middle of the PERF 'renovation' we find that there will be a new Police Chief navigating the ship. Hopefully this individual will move swiftly. Some thought might be given to the following:

- **Discipline:** We need to settle all pending disciplinary matters (including grievances). The Chief and the SFPOA should meet until those settlements take place and, if we can't reach agreement, then the same parties should mediate with the Police Commissioner assigned to the case. Sure, there will still be trials, but, hopefully, only in the most exceptional of cases.
- **Medals of Honor:** There is a very simple way to expedite all Medal of Honor applications (and make it a lot easier to have our sergeants/lieutenants to prepare the appropriate recommendations without the current duplicity involved.) It's hard to believe that the officers who put their lives on the line last Christmas having to dispatch the tiger that had killed and maimed victims at the SF Zoo have still not been honored by this Police Administration. The very same officers have been awarded SFPOA Medals of Valor and, in addition, Medals of Valor from a Southern California Organization — but nothing from the San Francisco Police Department.
- In addition, **Captain Paul Chignell's** Ambassador Program should be implemented City-Wide.

(Paul developed a program that helps citizen-victims work within 'the system'.) Paul has one of his district sergeants contact victims of every crime perpetrated in the Taraval District and made sure they knew exactly what was going on with their case. The days of petty politics overshadowing such a great public benefit need to be gone.

A remarkably dangerous ex-convict fired his 9mm semi-automatic weapon directly in front of a security guard in an attempt to intimidate the guard from doing his job. This took place in front of one of the many nightclub operations in the South of Market neighborhood. The armed suspect never thought someone just might call 9-1-1 and report him — but they did. Sgt. Joshua Espinosa, Officer Joselito Sy, Officer Melissa Benzinger, Officer Tom Hauscarriague, Officer Timothy Kiely, Officer Kevin Lyons, Officer Paul Rueti, Officer Joseph Sharlow, and Officer Josh Tiimalu responded to the area, conducted a lengthy search for the suspect and eventually located and arrested him.

Roommates arriving home late on the 700 Block of Gonzalez watched as someone was going through their home with a flashlight. This was especially unnerving as no one had permission to be inside. A quick call to Dispatch and Officer Jeffrey Fortuno, Officer Peter Kent DeJesus, Officer Sandon Cheung, Officer Joaquin Borromeo and Officer Wayne Wong responded. As the officers were setting up their perimeter, the suspect made a run for it. Nice try. Suspect, burglary tools, and a fresh arrest warrant from an outside jurisdiction finally caught up with him.

On December 5, 2008, there was a fatal hit and run accident that claimed the life of a pedestrian crossing Lake Merced Boulevard. The suspect driver, for whatever reason, kept going. Just 3 days later and Officer Dennis Cravalho and Officer Timothy Whatley were investigating a suspicious call on the 200 block of Vidal Street. Turned out that Dennis and Tim managed to get enough evidence from that call to nail the hit/run suspect and arrest him for vehicular manslaughter and other charges.

Seems like everything is taking a tumble in this brutal economic downturn except for the business of dealing narcotics in San Francisco. Sales, apparently, are still booming. Take the case of the individual who was driving a brand-new Mercedes late at night at a high rate of speed — again in the South of Market Party Lane. Officer Sean Frost and Officer Sean Cronin attempted to make a traffic stop but the suspect drove too fast for conditions so Sean and Sean dropped off, rather than endanger the public. 24-hours later Officer Frost and Officer Marcus Dobrowolski found the same car driving by after leaving a Club and, when they tried to stop him, the driver

again took off at a speed more reckless than necessary. The car, however, did turn up at another club a few hours later. A surveillance was set up to find out why the man was so afraid of being the subject of a police officer's inquiry. The individual returned to his vehicle and, seeing uniform officers nearby, tried to run away. He was detained and relieved of a fully-loaded, .45 caliber, semi-automatic handgun as well as a large assortment of narcotics and \$7,000.00 cash. In addition to Sean, Sean, and Marcus, the 'pharmaceutical salesman' was waylaid by the following officers: Officer Richard Yick, Officer Joe Salazar, Officer Arthur Madrid, Officer Robert Walker, Officer Tim O'Connor, Officer Jennifer Dickson, Officer Daniel Reyes — all under the tutelage of Sergeant Carlos Gutierrez.

There was a silent alarm on the 200 block of Post Street related to one very high-priced fashion store. The 2 suspects who had broken in took the following items: A woman's brown leather jacket valued at \$4,500.00, a pair of brown sequined shoes with a \$1,000.00 price tag, a brown leather handbag worth over \$2,000.00, and a few other items bringing the total take to over \$15,000.00. The 2 color-coordinated 'shoppers' were soon apprehended by Officer Anna Patterson, Officer Oliver Lim, Officer Matt Sullivan, and Officer Vien Lam. The supervising sergeant who responded to the arrest, Sgt. Paris Deshong, summarized the entire escapade in one word: "Priceless."

## Police Personality of the Month

### From the Archives: S.F. Policeman, October 1959

One of the last of the real two-fisted "San Francisco" cops is a veteran Inspector George Dyer, Sr.

One of nine children, George was born at Twenty-First and Alabama Streets. His father was Chief of the Southern Pacific Railroad Police Force.

George entered the Police Department in 1925 and, during the next twenty fabulous years, served well in every phase of the job: radio cars and beats in the Richmond and Southern; Special Duty Man at the Southern; Chinatown Detail; Flying Squad; Bureau of Inspectors.

Old timers tell stories of Dyer's courage. The time he leaped through a skylight in the Richmond District to disarm a crazed, shotgun-wielding murderer; the numerous gun battles with bandits and killers. Three Meritorious Conduct Awards and scores of commendations fill his personnel file.

The general strike of 1934 had erupted into violence. Dyer, coupled with Al Torre (now inspector), to form a two man police force on the Embarcadero. Troublemakers who were willing to tangle with a platoon of policemen turned tail and fled when the word was passed: "Look out, here come Dyer and Torre!"

In World War II, a vicious hoodlum element had sprung up, Dyer was chosen to head a special flying squad to

fight fire with fire. Sweeping through the Mission, Tenderloin, and Fillmore, the squad broke the backs of the mobs. Many an ill-mannered ruffian under estimated the 5'9" Dyer and nursed a broken jaw in his jail cell.

During his twenty years in the Bureau, he has worked the Bunco, Auto, and General Work's Details. He now serves as a right-hand man to Lieutenant Donald Scott in General Works.

It is a luckless culprit whose case is assigned to Dyer. The gates of San Quentin have closed on many who would match wits with this master detective.

George's brother, Jack, long a Sergeant in the B. S. S.; Gambling Detail, died in 195

Inspector Dyer resides with his wife, May, in the Sunset. His son, George, Jr. ten years in the business, is assigned to the Burglary Detail.

A model for young police officers is George Dyer. Soft-spoken, mild mannered and gentle; but a fearless fighter when called upon to defend law and order.

### Mobster Sues SFPD Citing Rousting by Inspectors George Dyer and George Page

Mickey Cohen, Los Angeles soda fountain proprietor and erstwhile mobster, has taken legal action against the San Francisco Police Department. He filed a federal court suit seeking an injunction to prevent Chief Thomas Cahill from giving him what the underworld commonly calls a rousting. Cohen charged that when he last visited San Francisco to confer with his biographer, Dean Jennings, he was harassed and hounded by Cahill and two police inspectors and ordered to leave town. They detained him without charge and searched his room without a warrant, Cohen maintained. To all of

this Cahill responded frostily: "I have a sworn obligation to the people of San Francisco to protect them."

Editor — When I was in the Fraud detail in 1973, I shared a desk with Inspector Frank Gibeau. He told me then that my uncle, Inspector George Dyer, and his partner, Inspector George Page, were the two that arrested LA gangster Mickey Cohen. I went to the ID Bureau and pulled Cohen's rap sheet. Sure enough, there was an arrest by Inspectors Dyer and Page at the train depot at 4th and Townsend Streets for "Vagrancy." —Mike Truman

### Lifetime Achievement Award

## Captain Greg Corrales

Captain Greg Corrales was born in Hayward, California on 19 April 1948. He proudly served in the United States Marine Corps from 1966-1969. On September 1969, Corrales entered the SFPD Academy.

Since his career started with the SFPD in 1969, he served in the Tactical Unit, Narcotics Division, Street Crimes Unit, Ingleside, Mission, Central, Potrero and Northern Stations, and as Night Captain. He commanded the San Francisco General Hospital Institutional Police, the Auto Theft / Burglary Detail, the Hit & Run Detail, the Arson Detail, The Narcotics Division, and Ingleside and Mission Police Districts. He is currently in command of the SFPD Traffic Company.

He has been awarded the Gold Medal of Valor, two Silver Medals of Valor, six Bronze Medals of Valor, and two Police Commission Commendations.

He is the recipient of two Chief

of Police Commendation for Service Awards, two San Francisco Board of Supervisors Certificates of Honor, and a San Francisco Mayor's Certificate of Honor. He has received Certificates of Appreciation from the FBI, DEA, California Bureau of Narcotic Enforcement, and the California Narcotics Officers Association. He has also been awarded a Citation for Exemplary Performance of Duty.

Captain Corrales holds a Bachelor of Public Administration degree from the University of San Francisco. He holds a Community College teaching Credential, as well as a Certificate in Criminal Justice from UC-Santa Barbara. He is a graduate of the 170th Session of the FBI National Academy.

Captain Corrales' grandparents were born in Mexico and came to this country shortly after the turn of the century. His father, Rosalio Corrales, instilled in Greg a fierce pride in his Latino heritage. He is a charter member of the San Francisco chapter of the Latino Peace Officers' Association, for which he served many years as chapter president. Captain Corrales has four children and has been happily married for nineteen years to his wife, Liane.

# Ask Mike...the Retiree's Corner

**Q.** Mike, I heard that Clare Murphy, executive director of the Retirement System, is retiring?

**A.** Yes, it's true. After 40 years as a city employee, Clare Murphy has announced her retirement effective January 2010. Clare has served as executive director of the Retirement System since 1984. The Retirement System has engaged the services of a search firm to help in hiring a suitable replacement for Ms. Murphy. It is anticipated that a new executive director will be hired by September 2009 so as to allow a 4 month transition. This new executive director will serve at the pleasure of the Retirement Board. The POA hopes that current Retirement System management employee(s) will submit their application for this most important position. For retirees, the two city agencies that are of utmost concern are the Employees' Retirement System and the Health Service System. Ms. Murphy has been an outstanding leader protecting the System's assets and enhancing retirement benefits over her long tenure. She, the System's financial/investment team, and the 7-member Retirement Board are to be congratulated for crafting the System's well diversified portfolio that has so ably weathered the current financial storm.

**Q.** Mike, I have heard that the Retirement System has suffered a "big time" loss in its investments from which our monthly pensions are paid? Are our pensions in jeopardy?

**A.** It is accurate that the Retirement System's trust fund has sustained a considerable decrease in value; as of October 31, 2008 its market value was \$12.8 billion down from \$15.8 billion as of June 30, 2008. This is a loss of 18.4%. But some context and perspective is needed to evaluate this loss. It is mostly due to the decline in stock prices especially the dramatic decline in the month of October. Already, the fund has recovered some of this loss with the rising stock market in November and December. During this same period of time, the California Public Employees' Retirement System (PERS) — the largest public pension in the U.S. — sustained a loss of 31% which is one of its worse declines since its inception in 1932. PERS is now asking local governments for larger contributions to buttress the fund. PERS delivers pension payments to 1.6 million retirees/beneficiaries. CCSF retiree/beneficiary pensions are not in jeopardy. Our Retirement System has adequate reserves, earnings, and continuing contributions (members and CCSF) to meet all its pension obligations. It remains one of the best funded pension funds in both the state of California and in the United States.

**Q.** Mike, I have heard that many, if not most, police officers die within 5 years of their retirement? Is this true? I am 10 years post-retirement. Should I be expecting the grim reaper any time soon?

**A.** The very good news is that this "die within 5 years of retirement" is not now true and has not been true for more than

60 years. In 1949 the Charter was changed to set age 55 as retirement eligibility for police officers. Prior to this time, police officers retired in their early to mid 60's and did have a short retirement. In 1969 that eligibility age was reduced to 50 although most police officers now retire in their mid-50's given the current pension calculation structure (3% at 55). If you follow the Widows and Orphans' Aid Association reports in each month of the *POA Journal*, you will see that police retirees' deaths are clustered in the 70-79 and 80-89 age ranges. My personal goal is to make it to at least 108. While my chances are currently less than 2% to hit 108, they are nearly 4% that I could make it to 100. I urge police retirees to plan for a long life span and not to forget the "Hebel Rule #1" — aim to collect retirement benefits for at least as long as you worked for the SFPD.

**Q.** Mike, I remember my mother, father, and grand-parents describing their experiences during the Great Depression of the 1930's. Are we now headed for a similar experience?

**A.** The stunning collapse of global stock prices and the downfall of major banking institutions have led most Americans, according to a recent CNN poll, to believe that we are heading for another Great Depression. But let's look at the hard economic facts to dispel this belief. During the Great Depression, the stock market lost 88% of its value; our current stock averages are down about 42%. During the Great Depression, one out of every 6 Americans was unemployed; today, one in 16 is out of



work. During the Great Depression the U.S. economy, as measured by gross national product, shriveled nearly 15% a year for many years in the 1930's; today we are in recession, but the economy has shrank by less than 1% in the last year. Another Great Depression could happen which would further hammer stocks, bonds, and real estate. But I most certainly believe that we are not now entering into another Great Depression. As bad as things seem now, we have been through much worse, yet our economy not only survived but prospered. It will do so again. Betting against America and its powerful economic engine is not a path to wealth.

## Great West Assumes Management of the City Account

# "So, You Have No Interest In Seeing China, Eh?"

I've known Jim Hennessy for (God) 38 years. I was a newbie on the original Honda Unit in 1970, and Jim was a studly mounted officer — both assigned to Golden Gate Park.

Jim's "Hobby Job" has been as an erstwhile travel agent/consultant, and in his retirement, has ramped it up, taking folks (usually retired cops) all over the world on vacations. Jim's specialty has been China, but I, like many folks I usually travel with, really didn't have much interest in seeing "The Peoples' Republic." After all, I've already driven down Irving Street and I figured I'd seen pretty much all I needed to see.

But I kept hearing glowing reports from folks who did make the trip with Jim to the Orient, and began to wonder what all the commotion was about. For Years I had been forwarding Jim's travel announcements to my rather extensive police email list, then later hearing back that they had the trip of a lifetime!

So, after noting that many really stand-out people I had worked with in the past (Ken Foss, Alex Fagan, Stew Flynn, Barron Fong, Frank Harrington

I'm told this may be Hennessy's last trip to China, as he is now specializing in South East Asia (Viet Nam, Cambodia, Thailand, etc) and if I hadn't worked so hard avoiding that part of the world in 1966, I might consider the trip.

On second thought, Ho Chi Minh is dead, Jane Fonda is minding her own business and Jim Hennessy is running the show...I just might think about it.

and Karen Petromilli, Ken Moses, Mike Zurcher), plus a couple retired Oakland PD Solos I have occasioned to, eh... well, you know, "hang with" we're signed-up to go, I decided what the hell, I better do this before I wake-up drooling on myself.

So before I knew it, I'm going to China!

The first thing I noted is Jim Hennessy has done this trip so many times (17) that he leaves nothing to chance. Remember, we're dealing with a cumbersome Communist Bureaucracy here (I'm talking about China, not San Francisco) and the hurdles are substantial to say the least. Even the most neophyte traveler feels confident in Jim's pre-preparation and tutelage.

I'm not going to get into "What I Did On My Summer Vacation" here, I just thought I'd point-out some of the observations of our three weeks in the Orient that stuck out in my mind.

All of the accommodations we stayed in were absolutely first-rate! I've been all over this amazing world and to call them five-star is an understatement. Hotel staff treat you like royalty, and Westerners always receive preferential treatment over their own people. Meals, with very few exceptions, were great, and a note-worthy aside, I came home eight pounds lighter than when I left, owing to healthy food and

a pant-load) was spotlessly clean and modern. I never once saw any graffiti or so much as a paper in the gutter. That being said, the Chinese use their rivers as sewage dumps. No one in China, including the Chinese, drink water from the tap.

On our otherwise awesome 3-day boat trip down the Yangzee River to the new Three Gorges Dam, we were treated to the sight of floating detritus, trash, dead livestock, and God knows what else floating with us downstream. How a country of 1.3 billion people think they can continue to use their rivers as septic systems boggles the mind.

Another weird deal, is the Chinese consider someone emitting a belch after dinner as just this side of child molestation, but don't think twice about hocking a sinus-clearing glob on the ground, and that includes indoors!

As I've stated earlier, I've done a lot of traveling, and almost always picked-up enough of the local language in two or three weeks to ask directions, or find a cold beer. Not here. The only two words I learned were: Thank You (Shae-Shae) and Beer (Piju), and I'm pretty sure those aren't the correct spellings. The Chinese couple (Ray and Betty Gee) that were traveling with us are Cantonese speakers, and had the very same confused looks on their

# Book Reviews

## A Most Wanted Man

By John Le Carre

I have read many of Le Carre's books, going back to the early 60s with his *The Spy Who Came in from the Cold*. Through the years, he has been consistently successful at both writing interesting novels and selling them. His plots are always complex and fascinating, his characters memorable. *A Most Wanted Man* continues those characteristics but somehow, this novel is different, of a lesser quality. Then again, perhaps I'm wrong as the book remained on the best-seller lists for months.

I believe that Le Carre wants to be perceived as Graham Greene's equal. Only time will reveal whether that is true, but for me Greene was considerably more talented and important.

There are three main characters in this story; Issa, a very strange young Muslim who claims he is from Chechnya; Annabelle Richter, an idealist lawyer who attempts to prevent Issa from being deported and assists him in claiming a large sum of money that had been surreptitiously deposited in a bank in Hamburg, Germany that is run by Tommy Brue, a British heir to the bank and all its dark secrets. The setting for the novel is Hamburg, the city where many of the September 11 murderous terrorists lived and worshipped. Issa and Annabelle present a strong case to Tommy that he is the rightful heir to a fairly large fortune that was paid to his Russian colonel/gangster father by the British secret service. The money was laundered through Tommy's bank when his father created what is referred to as *The Lipizzaner Accounts*, named thus because the Lipizzaner horse is born black and turns white with age.

After a lengthy introduction to these three the reader meets the German spy Gunther Bachmann. Bachmann is the consummate modern-day spy, never giving a second thought to doing evil in defense of good. Bachmann and his team discover that Issa is in their city

and begin to develop an investigative case file but discover many more so-called intelligence officers, from other countries are also interested in Issa. Le Carre has always been good at describing how espionage works, or occasionally works badly, and this book is no exception. 9/11 may have happened more than seven years ago, but blue-flame heat is still felt inside the people charged at preventing another such catastrophic mass-murder. And the agencies involved apparently haven't yet learned the value of sharing information or of coordinating tactics when dealing with a common enemy. Le Carre has also been excellent at describing how moral questions seem to be flexible, not rigid. He describes the wearing away of moral standards as situations change, of how evil has a way of breaking strong people. It is easy for the reader to believe something is clearly true, only to discover later that there was absolutely no truth to any of it. Tommy tries lying to the spies, only to have them offer him an opportunity to be even more deceitful in order to keep his bank intact and avoid prison. As the story unfolds the reader begins to question everyone's motives. It's safe to conclude that nothing is as it seems.

My biggest complaint, and here I recognize my bias, is that the book is, at times, so strongly anti-American. As savage and heartless as the German and British spies are, they perform their functions with the cover of good manners. Not so the Yanks. They are rudely savage. The laws and lawyers are mere speed bumps to be bull-dozed over.

When the Berlin Wall came down and the so-called Cold War came to a close it looked like Le Carre would have to find a new subject. The new, not-so-cold wars the world suffers have provided him with new material. His writing is almost always beautiful and his stories clever. Therefore, I'm expecting to see more from him, but I'm hoping he will try to find less vitriol in his descriptions of us.

## Nothing To Be Frightened Of

By Julian Barnes

Julian Barnes is both a wonderful novelist and an eagle-eyed social observer. His writings have won him fame and many awards. He is now in his mid-60s and, as many people do when we reach that age, we seem to think more about death and our own personal dying than we had previously. What makes Barnes' thoughts on this subject worth your while is that he is so clever, so clear, taking a literally deadly-serious subject and making it much more than palatable. He truly makes clear why there is, as the title tells us, nothing to be frightened of.

Barnes lets us know that he doesn't consider this a memoir, but he examines his parents' lives and demise, his relationship with his philosophy-professor brother and his career outside his writing life. And he does it all with a great deal of humor. It seems that every page has one or more sentences that are hilarious. Jokes about death? Not jokes, but humor. He quotes Somerset Maugham's view about the subject as being "the best frame of mind in which to conduct life is that of 'humorous resignation.'" As a matter of fact Barnes quotes a lot of writers, mainly French. One he introduced me to, happily so, is Jules Renard. Barnes' writing is filled with irony and he quotes Renard to explain why that specific literary technique works so well, especially for this subject: "Irony does not dry up the grass. It just burns off the weeds."

Here is another perspective from the author that displays what I have tried to describe above. He encourages himself and the reader to imagine one's own passing, "...through the eyes of others. Not those who will mourn and miss you, or those who might hear of your death and raise a

momentary glass; or even those who might say 'Good!' or 'Never liked him anyway' or 'Terribly overrated.' Rather, one must see death from the point of view of those who have never heard of you — which is, after all, almost everybody. Unknown person dies: not many mourn. That is our certain obituary in the eyes of the rest of the world." How can you resist reading more from this fearless, droll intellectual?

Obviously, what the author must address in this discussion is a fear of God, or there not being God. The very first line of the book is, "I don't believe in God, but I miss him." His philosopher brother chides that thinking as "soppy." The word is defined as "silly or foolish in a feeble or self-indulgent way." Nothing about Barnes' writing is feeble or foolish, forcing me to conclude that his brother is a bit too stuffy for me. Occasionally he may be wistful, often ironic, frequently funny but never foolish. Barnes does explore many post-death scenarios, never really deciding upon one that he believes is best. One of his best lines is regarding Pascal's wager: "What if it turns out that God does exist but disapproves of gambling?" Hmm.

The physical make-up of the book is one without chapters, much like a very long essay. There are, of course, breaks, but I would have liked titles to sections so that when I wanted to look back on something specific I could more easily find it. And because I found the book so full of great quotes and insight there have been many times I wanted to find specific lines. Perhaps Mr. Barnes knows exactly what he was doing, however, as each time I went back looking for a specific idea I found something equally as good. I believe you will have much the same experience should you read this. You might even find yourself looking for more of his writings.




## New York City Police Union Criticizes Effort to Reduce a Pension Benefit

It is as ingrained a catchphrase for city police officers as "New York's Finest." It is "20 and out," and officers know it means if they have 20 years on the job, they can retire with a full pension.

Gov. David A. Paterson's proposal to extend that length of service to 25 years for new hires was met with sharp criticism on Wednesday by the union representing police officers, where it was seen as a callous disregard for the tolls of police work. The city portion of the proposal was developed by Mayor Michael R. Bloomberg, and is estimated to save the city \$5.4 billion over the next 20 years.

The proposal also includes creating a minimum retirement age of 50 before a full pension can be received. There currently is no minimum retirement age, and many officers who retire after 20 years are in their early 40s. The rule of "20 and out" would effectively become "29 and out" for a 21-year-old recruit.

The changes, which would also affect the pensions of firefighters, would require City Council approval as well as passage in Albany.

Patrick J. Lynch, president of the Patrolmen's Benevolent Association, the union representing police officers, said changing the pension was breaking a longstanding promise to new recruits.

"For decades, the city has managed to pay less than a market rate of pay for dangerous emergency service jobs because of the promise of stability and a fair pension," Mr. Lynch said in a statement on Wednesday. "Remove those incentives and no one will want to take the risks or suffer the physical and mental toll those jobs inflict."

After 20 years on the force, the average New York City police officer earns roughly \$90,000 annually, including overtime pay and other salary enhancements, said Charles M. Brecher, research director at the Citizens Budget Commission.

With a pension worth half of the final year's annual salary, plus a \$12,000 annual lump sum payment called a variable supplement, a retired officer can receive roughly \$57,000 a year, which is not subject to state or city income taxes, he said.

"It's an expensive system, and generous, compared to other public employees," Mr. Brecher said.

Under the proposal, the \$12,000 annual payment would also be elimi-

nated, and the pension would be calculated using an average of salaries for the final three years of employment, not the last year.

E.J. McMahon, a senior fellow at the Manhattan Institute for Policy Research, said the governor's proposals would fix an outdated system and help rein in the city's rising pension costs.

"'Twenty and out' reflects an era where, after 20 years of police work, if you were in your early 40s, you did not necessarily have that much longer to live," Mr. McMahon said.

He said the pension for city police officers was so known for being lucrative that, unlike other municipal employees, "police officers are the only ones who have the pension in the back of their mind when they take the test in their early 20s."

Eugene J. O'Donnell, a professor of law and police studies at John Jay College of Criminal Justice, said it was hard to determine the effect that a less generous pension plan would have on recruiting. One problem, he said, is that the Police Department seemed to be downsizing somewhat and doing little recruiting, and moreover, the sharp increase in unemployment had made it easier to recruit future cadets.

Robert W. Linn, a former director of labor relations for New York and the president of a labor relations consulting firm, said that the overall compensation package should be re-examined. "If, in fact, New York City base salary is not competitive and the pensions are worse than in other jurisdictions, it will be hard to attract police. It should be no problem attracting people with 25-year pensions if base compensation

is also competitive."

In August, the police unions and the city reached an agreement that would increase starting pay to \$41,975, up from \$35,881 under an old contract. It followed an arbitration panel's awarding police officers a retroactive raise while significantly raising starting pay to \$35,881, from \$25,100.

At Columbus Circle, two officers emerging from the underground police command center said the proposed changes might give prospective officers some pause.

"Being a police officer is a hard job," said a 23-year-old officer with two years in the department, who spoke on the condition of anonymity so as not to violate Police Department rules. A pension in 20 years was a draw to this career, he said. "An extra five years isn't bad, but if you work in the busy houses, it can burn you out."

Professor O'Donnell said many of his students who planned to join the Police Department were attracted to this year's increase in starting salaries for officers and paid little attention to pension issues.

But Steven Heimer, 21, who had just completed his police final minutes before, said the new proposals might deter him from joining the department.

"Twenty is a big difference from 25," he said. "If you want to do something afterward, have your own business, you'd have to wait five years."

Another John Jay student, Derek Bruno, 22, just shrugged when told of the proposed changes. "I don't care," he said. "I've wanted to be a cop since I was 13."

## Denver Seeks 2% Pay Cut From Cops, Fire Crews

Mayor John Hickenlooper has approached three unions for help to ease a budget crunch.

Mayor John Hickenlooper's administration has asked the unions that represent Denver's police officers, firefighters and sheriff's deputies to renegotiate salary contracts and accept a 2 percent salary cut next year.

Kelly Brough, the mayor's chief of staff, confirmed that she and other administration officials have been meeting with all three unions to come up with ways to close a mushrooming budget gap for next year. She said she asked for the wage concessions during those negotiations.

"We went to the unions and said we want to work with you and spread this out and keep everyone here," Brough said. "There is nothing harder on a family or community than when people lose their jobs."

At least one union, the Fraternal Order of Police, which represents sheriff's deputies, has rejected the offer. That union's response, articulated in a letter to the membership, has created concern among rookie deputies and recruits that the city will lay them off.

Corrections director Bill Lovingier met with about 50 of the deputies and recruits Thursday morning and tried to calm some of the concern, but those who attended remained nervous.

One deputy who attended said the message was that if the contract doesn't get renegotiated, then the city will start laying them off.

Lovingier said he was trying to reassure those he called to the meeting that layoffs, although a possibility, were a long way off.

"I assured them that what they were hearing were rumors, and they should sleep well and have a wonderful

Christmas," Lovingier said, although he confirmed that the Fraternal Order of Police and administration were at odds on salary concessions.

Brough said the administration is facing a difficult budget situation for the next two years given the slumping economy.

She said the discussions with the unions are part of a comprehensive approach the administration is crafting. Brough said wages and benefits were negotiated with the three unions when times were more flush. The unions represent employees of departments that take up roughly half the city budget.

"We're still looking at other ways we could trim our budget, but it's difficult at this point to find additional opportunities," she said.

The contract calls for a 4.75 percent wage hike for police officers in 2009, 4.5 percent increase for sheriff's deputies and 4 percent jump for firefighters.

Brough said the administration will unveil next week more precise dollar figures on the amount of savings it is seeking and some actual cuts. In 2003, when Hickenlooper first took office, the firefighters and sheriff's deputies agreed to wage concessions while the police declined.

She said she remains "optimistic" that the administration will reach an understanding with the Fraternal Order of Police, which represents the deputies.

This time around, the Police Department seems more willing to negotiate.

"We may be looking at hard times," said Detective Martin Vigil, the president of the Denver Police Protective Association, which represents officers.

Eric Tate of the Denver Firefighters Local 858, said the union is hiring a consultant to conduct its own analysis of the city's finances before responding.

*Cases Part of Multi-Agency Effort to Combat Crime Against Seniors*

## Suspects Charged with Elder Abuse in Two Separate Incidents

SAN FRANCISCO — The San Francisco District Attorney's Office has charged John McTaggart, age 45, with fraud and theft from an elder for allegedly stealing \$140,000 from an 86-year-old San Francisco woman as part of an annuity scam.

"With the coming holidays and the looming economic crisis, people are in desperate times. These are the moments when we see an increase in exploitation and abuse of vulnerable populations, like seniors. Nearly 20 percent of San Francisco's residents are seniors," said District Attorney Kamala D. Harris. "Yet too often they are the invisible victims of crime in our City. We cannot allow criminals to prey on our elders. Now more than ever, our seniors need help and protection so they don't fall victim to financial crimes and elder abuse. If you have seniors in your family or as a neighbor, check in with them. They need our help understanding fraud and ID theft risks, and we should protect our elders," DA Harris added.

According to court documents, in February 2008 defendant McTaggart,

a former broker, convinced his elderly victim to sign over \$140,000 in monies received through a legitimate reverse mortgage he had helped the victim secure. Once the victim received the money from the reverse mortgage, the defendant allegedly convinced her to dedicate a portion of the funds to an annuity account. Instead of depositing the victim's money into an actual annuity account, he had the money sent to his personal account. The defendant then allegedly attempted to mask this fraud, by sending monthly checks to the victim, essentially paying her "dividends" from the money he had stolen directly from her. Defendant McTaggart then fled to Tennessee, where he is now awaiting extradition on a DA warrant that was issued on November 24, 2008.

This case is being prosecuted by Assistant District Attorney Alan Kennedy. Inspector Greg Ovanessian is the leading the SFPD investigation. The San Francisco District Attorney's Office and the San Francisco Police Department are two of the partner agencies in the San Francisco Elder Abuse

partnership designed to enhance the effectiveness of the assessment, investigation, and prosecution of elder and dependent adult abuse cases in San Francisco. The collaboration was launched early this year and has processed over 100 potential cases to date.

The San Francisco Elder Abuse Forensic Center includes the following stake-holder agencies: Adult Protective Services and Public Guardian (both divisions of DAAS), District Attorney (prosecutors and victim services), Police Department (police inspectors, fraud and domestic violence specialists), the Ombudsman, and the private partner, Institute on Aging—Geriatric Assessment Center and Elder Abuse Prevention Program, along with a board certified geriatrician.

The Center, housed in the Department of Aging and Adult Services, co-locates experts from each of these agencies crucial to managing elder abuse cases, and provides the venue and mechanism for rapid and efficient collaboration. The team provides multi-agency case reviews and action plans, and conducts in-home medical and mental status evaluations, evidentiary investigation and multidisciplinary consultation.

Another case recently handled by members of the San Francisco Elder Abuse Forensic Center involves Shirley Guzman and Rebecca Enrile, two former in-home caregivers, who were arrested for elder financial abuse on Wednesday, November 26, 2008 and made their initial court appearances on December 1, 2008. Defendant Enrile has been arraigned. Defendant Guzman is scheduled for arraignment on January 9, 2009. Defendant Enrile

will also appear on this date. This case is significant as it is the first case to go to court that has been processed by partner agencies of the San Francisco Elder Abuse Forensic Center.

The former caregivers are accused of defrauding a 93-year-old widow in their charge of over \$115,000 by inappropriately cashing checks that were meant for groceries or household expenses, and by opening credit cards in her name.

"One of the primary goals we had when the Elder Abuse Forensic Center was created, was to make our seniors safer by increasing the number of prosecutions of people committing crimes, especially fraud, that victimize vulnerable elders," said Anne Hinton, Executive Director of the Department of Aging and Adult Services. "These two cases exemplify the results this level of collaboration can bring."

Reports of elder abuse have risen in recent years. Last year, the Department on Aging and Adult Services — Adult Protective Services division received almost 4,500 new reports of elder abuse, up from just under 4,100 in 2006; and over the last three years, the District Attorney's Office has prosecuted 52% more elder abuse cases. The social, medical and law enforcement services needed to deal with this growing number of victims are spread across various City Agencies and Community Providers. The San Francisco Elder Abuse Forensic Center brings these important resources together to prevent delays and gaps in service coordination, evidence collection and criminal investigation that could otherwise negatively affect the outcome for victims of abuse.

## From the District Attorney's Office

### Defendant Arraigned for Cold Hit Case of Rape and Murder in 1991

SAN FRANCISCO, CA – District Attorney Kamala D. Harris announced the arraignment of Otis Hughes, age 56, and CTN 2397734, for the 1991 rape and murder of then 38-year-old Karen Wong.

Defendant Hughes is charged with one count of murder in violation of Penal Code section 187(a) and one count of rape by force in violation of Penal Code section 261(a)(2) with an allegation of the use of a deadly weapon pursuant to Penal Code section 12022(b)(1) and an allegation of special circumstance for murder committed during the commission of rape.

Defendant Hughes pleaded not guilty to all charges before Judge Tomar Mason on Friday, December 12, 2008 in San Francisco Superior Court Department 9. The arrest and prosecution of Otis Hughes is the work of the Cold Hit Units of the San Francisco Police Department and the San Francisco District Attorney's Office.

In 2006, San Francisco District Attorney Kamala D. Harris secured \$400,000 in federal funding from Senator Dianne Feinstein to create a coordinated unit dedicated to the investigation and prosecution of "cold cases." In the case of defendant Hughes, SFPD Inspectors Joseph Toomey and Holly Pera are the police investigators and Assistant District Attorney Braden Woods is the prosecutor.

"It has been nearly 20 years since this woman was raped, hogtied and stabbed to death in her own home, but our commitment to bringing her killer to justice has not wavered," said District Attorney Kamala D. Harris. "The intense work of our Cold Hit Unit to investigate unsolved cases means that victims and their families can finally have the justice they seek and dangerous criminals are being taken

off our streets."

According to Court documents on February 27, 1991, after a couple of days of not hearing from the victim, Karen Wong, the victim's boyfriend contacted her brother who also had not heard from his sister in several days. Together the victim's brother and boyfriend went to the victim's home to check on the victim. When they arrived they knocked on the front door and no one answered. Then they entered the victim's home through the back door to find the victim dead. Her body was hogtied. The evidence gathered showed that the victim had been sexually assaulted and murdered. Semen recovered from her body was kept in CODIS, a DNA database, for further investigation.

In October 2008, a match between a CODIS contributor and the sample DNA collected at the crime scene was found. The CODIS sample was identified as belonging to defendant Hughes, who as a result became a suspect in the unsolved murder and rape of Karen Wong. Police and prosecutors from the Cold Hit Units of both the San Francisco Police Department and San Francisco District Attorney's Office reopened the case and re-investigated the case, which later led to the issuance of a DA warrant and subsequent arrest of defendant Hughes.

Defendant Hughes was arrested on Tuesday, December 9, 2008 at his home in Richmond, California. Defendant Hughes had just been released from state prison where he had served the last 17 years for residential burglary convictions out of San Francisco. He is currently being held in San Francisco County Jail on \$2 million bail.

The defendant's next scheduled appearance is at 9 a.m. on January 9, 2009 to set date for preliminary before Judge Tomar Mason.

### 32 Years to Life in State Prison

### Defendant Sentenced for First-Degree Murder, Attempted Murder & Robbery

SAN FRANCISCO, CA – District Attorney Kamala D. Harris announced today that Chad Dias, age 23, Court Number 2207471, was sentenced to 25 years to life with the possibility of parole for one count of murder in the first degree, life with the possibility of parole for one count of attempted first-degree murder and a three-year stayed state prison sentence for one count of robbery. The sentences on the first two counts are to be served consecutively, meaning that the defendant would have to serve a minimum of 32 years in state prison before becoming eligible for parole. The defendant was also ordered to pay restitution.

This defendant will spend the better part of his adult life behind bars as a result of the conviction," said District Attorney Kamala D. Harris. "The violent conduct for which he was prosecuted, convicted and sentenced was outrageous and warranted this outcome."

The sentence was handed down by the Honorable Carol Yaggy in Department 28 of San Francisco Superior Court on December 12, 2008. Judge Yaggy allowed the defendant and the victim's family to address the court.

The conviction is the result of a

lengthy investigation by Inspectors Steven Balma and Timothy Dempsey of the San Francisco Police Department's homicide detail. Jean Hassett and Jenny Lee are the Victim Witness Advocates assigned to the case. Michael Swart is the Assistant District Attorney who prosecuted the case.

After six-and-half days of deliberation, defendant Dias was found guilty by a jury on August 5, 2008 at the end of a two-month trial before Superior Court Judge Carol Yaggy in Department 28. He was convicted for his role in the March 1, 2005 shooting death of 22-year-old Christy Chan, the shooting and maiming of her 23-year-old boyfriend George Tang and the robbing of Mr. Tang of two pounds of marijuana.

Defendant Dias, of Richmond, was arrested on March 4, 2005. The defendant was originally tried for these offenses during a two-month trial that took place in August and September of 2007. The first trial resulted in a mistrial when the jury hung.

"The retrial and ultimate conviction of this defendant should send a loud and clear message that defendants will be made to answer for their crimes," said DA Harris.

## NICK'S NOTES





# My Northwest Escape



I had always wanted to sail the San Juan Islands in my boat Midget, and when the opportunity presented itself this past September I jumped at the chance. Midget is a Montgomery 15 with a beam of 6'2" and overall weight of 800 lbs. It's equipped with a "V" berth, portable head, 2HP Honda outboard and portable propane stove. When fully equipped for the trip the boat weighed about 1000 lbs.

I left the Bay Area the day after Labor Day for Bellingham, Washington, with Midget in tow and the long drive up I-5. I arrived at Bellingham Harbor Thursday, Sept 4th and launched the boat along with nine other small boat sailors. Departure for the San Juans was scheduled for the following day.

## Friday September 5th

I departed Bellingham Harbor with



the other nine boats about 8:30 AM. Our destination was Blakely Island Marina with a short stop at Inati Bay on Lummi Island. Due to the strong winds and tide we bypassed Inati Bay and sailed on to Blakely Island arriving about 4PM. Blakely Island Marina is a small quiet harbor surrounded by tall pine tree and green hills. Blakely is a private island with 55 residents and visitors are restricted to the marina grounds.

## Saturday September 6th

The fleet left Blakely Harbor for Deer Harbor on Orcas Island, and I had a great sail up the Harney Channel past Shaw Island and through the narrow Pole Passage and arrived at Deer Harbor around 2 PM. Orcas Island is one of the major islands in the San Juans serviced by ferryboat from Anacortes, Washington.

## Sunday September 6th

We left Deer Harbor around 10AM for Reid Harbor on Stuart Island. I took Spieden Island to port and arrived at Reid Harbor lat afternoon. The place was packed with large sailboats and motor yachts and it was necessary to raft up at the small dock. Reid Harbor is very rustic and the only concession to comfort is a long walk up a hill to a chemical toilet.

## Monday September 8th

The fleet split early in the morning with six boats headed for Sucia Island. Myself and three other boats headed across the Haro Strait for Sidney Harbor

on Canada's Vancouver Island. It was half sailing and half motor sailing to Sidney, and on arrival a very tedious Canadian Custom clearance by telephone. Sidney was a two-day layover and a welcome break from my own cooking. This was a first class harbor and had great facilities.

## Wednesday September 10th

We left Sidney for Roche Harbor on San Juan Island and on arrival had a much easier clearance through U.S. Customs. San Juan Island, the second largest island, was the site of the famous Pig War in 1859 that pitted the American against the British. Fortunately, the only casualty of the war was the pig. Roche Harbor is the prettiest harbor in all the islands. That night I had a fabulous dinner at McMillan's Dining Room over-looking the harbor.

## Thursday September 11th

The sail from Roche Harbor to Friday Harbor on San Juan Island was in light wind and a strong favorable current. I was moving at 5 knots but when I approached Friday Harbor a counter current slowed me down to 2 knots. After dodging the ferryboat at the entrance of the harbor I made it into a side dock in the harbor. Friday Harbor was a two-day layover. The other six boats arrived from Sucia Island and we were now a fleet of ten boats.



Friday Harbor is a neat town with lots of shops and restaurants, and it is the largest town on San Juan Island.

## Saturday September 13th

From Friday Harbor we motor sailed back to Blakely Island. The island store was closed for the season and I was back to cooking for myself. The quiet night at Blakely Harbor was interrupted when one skipper awoke at 2AM to find three mischievous river otters climbing all over his boat. The following day we would be heading back to Bellingham and the end of the trip.

## Sunday September 14th

We had a long way back to Bellingham and we left Blakely Island early in the morning. Initially the sailing was in light winds on the east side of Orcas Island, but as we rounded Carter Point on Lummi Island the wind picked up considerably. I put a reef in the mainsail and turned the motor on for the long sloppy ride back through Bellingham Bay. I was one of the last boats to arrive and I felt exhausted, but at the same time glad that I had made this trip. Total miles sailed: 110 nautical miles. The road trip was 1840 statute miles.

# THE LOONS NEST REPORT

## O'Reagan Victorious in Holiday Classic at Monarch Bay

The Loons Nest Golf Club traveled to San Leandro's Monarch Bay Golf Links for the twentieth playing of the Holiday Golf Classic. The event looked like a day at the British Open, as cold winds howled over a course that had been pounded by hours of rain the night before. Temperatures in the middle thirties greeted the first groups off the tee and through the course of the day a balmy high of 48 degrees was as warm as it got. The Loons played under some very threatening skies, as heavy storm clouds blew threw; but, there was only one three-minute shower that eventually moved on.

The course held up very well to the recent storm, as there was no standing water on the fairways or in any of the one hundred and sixteen sand traps. The American Golf Corp. has certainly done a fine job in their rebuilding of the course in recent years, with a very good drainage system. Monarch Bay was first designed and built by John Harbottle in 1958 for the City of San Leandro and the eighteen hole course is currently named for the late East Bay golf great Tony Lema.

The Loons enjoyed a breakfast buffet in the clubhouse before they hit the links and the warm food and drink was very much welcomed. The 2007 Holiday Classic Champion Steve Morimoto was unable to make a defense of his title due to work commitments at the Police Academy, but there was plenty of talent on hand.

As the winds blew and cold hands tried to feel the grips of the club, two loons managed to break forty on the front side. Darren Nocetti from Narcotics and longtime loon Brinney O'Reagan both posted matching thirty-nines. Five players sat in second place at the turn with scores of forty, which included Dave Kranci (Traffic Co.), Jim Ahern (Narcotics), Jim Enright and Dave Pomicpic of United Airlines and guest Mike Cullinan.



As O'Reagan moved through the back nine his putter got hot, as he picked up birdies on the sixteenth and eighteenth holes, while posting three birdies on the round. O'Reagan finished with a round of seventy-eight strokes. Nocetti ran into a double bogey six on the fifteenth hole, which moved Darren out of contention. Cullinan and Ahern were able to match their front side scores=20 with matching scores of forty on the back. As both players posted totals of eighty, the tiebreaker went to Ahern giving him second low gross in the first flight and leaving Mike Cullinan in the third spot.

In first flight low net play, Eric Valentini of Central Station made a big showing in his first Loon event. Eric fired an eighty-four and posted a net score of sixty-nine. Tim Lee matched that net score, but the tiebreaker went to Valentini. Valentini is making a comeback after he had been victimized in a traffic accident and sidelined for a substantial time. Eric not only returned to the links, but to the softball mound. Eric pitched Central Station through the semifinals in B-league action, as Central had the best regular season record due to Eric's prowess on the hill.

Mike Siebert from the General Work Detail took third low net in the flight with a net score of seventy. Mike was leading the pack through the eleventh hole, but a double bogey on the 549 yard par 5 twelfth hole was a big set back for him.

In second flight play there was quite a battle between Homicide's Mike Johnson and retired SFO Bureau veteran George Gulbengay. As the two men had completed seventeen holes, Johnson had a two-stroke lead with one hole to play. Gulbengay was hot as

he was coming down the final stretch having made par on the 16th and 17th holes. George made his third par in a row on the 18th leaving him at ninety-one strokes. Johnson ran straight into the teeth of a triple bogey seven on the final hole, leaving him in second place low gross, second flight. Steve Turdici posted a score of ninety-three to grab third place.

Second flight low net action saw Central's Mark Milligan run away with the show, as he posted a net score of sixty-seven strokes. Matt Hanley from the Auto Detail made a charge at Milligan on the front side, but still finished four strokes behind at seventy-one. Matt suffered double bogeys on the 12th, 13th and 15th holes, allowing Milligan to cruise to victory. Central Station's Eric Tapang grabbed third low net in the flight with a score of seventy-three.

Vince Neeson of Narcotics had a very good day in "Close to the Hole" contests. Vince took first place on the tenth and seventeenth holes, taking home two envelopes of side pot cash and two-dozen Taylor Made balls. Bob McMillan of GTF had the shot of the day when he put his ball one foot and eight inches from the cup on the fourth hole. The fourth hole was playing one hundred and sixty yards with a heavy crosswind coming off the bay and heading to the East Bay hills. Undaunted by elements or sand traps protecting the green, McMillan played the hole like a master. Brinney O'Reagan took first place on the 180 yard seventh hole with a shot three

feet, four inches from the hole. Second place winners were Tyson Bruce, Harry Pearson(Central), Jim Enright and Dave Pomicpic. The Loons assembled at the 19th hole for the awards ceremony, which brought the Loon's twenty-first season to a close.

# Close Encounters

So far, we have lost 140 Police Officers who were killed in the line of duty in the United States this year (as of 12/29/08.)

14 law enforcement personnel were killed in the state of Texas, the highest loss in the country. The second highest toll took place in California where we lost 12 officers. 41 officers were killed with firearms and another 71 were lost in traffic fatalities. The average age of the officers killed was 40 and the average length of time they were employed with their agency was 7.4 years.

Over 240 San Francisco Police Officers were mentioned in our column, *Close Encounters*, during 2008. In almost every incident in which the officers were mentioned, guns were involved. In almost every incident captured there was a serious risk where the officers placed their lives on the line to protect and serve. And, in almost every case, we could have lost another San Francisco Police Officer.

The names that are listed from the *Close Encounters* article are, by no means, the only reflection of heroism from SFPD personnel. There are so many other officers doing equally outstanding work day in and day out. We are limited in publishing such deeds by the information received. Hopefully, in the very near future, changes will be made where great police work can be documented without the formality required now, in a manner that will allow for supervisors to recognize great police work without having to sit behind a computer for hours on end duplicating the obvious...
